145. Crash Description/Narrative

Vehicle #1 was backing out of their parking spot in the parking lot of 588 Route 70 West (Fedex). Vehicle #2 was backing out of their parking spot diagonally from Vehicle #1 in the same location. Both vehicles struck each other in the middle of the parking lot. Both vehicles were moved prior to my arrival. No injuries were reported on scene.

Driver #1 stated she was reversing out of her parking spot in the parking lot of 588 Route 70 and there was a black Mercedes parked next to her, obstructing her view and she thought there was no vehicle behind her. There was minor damage to her back right bumper and tail light.

Driver #2 stated he was reversing out of his parking spot diagonally across from Vehicle #1. Driver #2 stated he didn't see Vehicle #1 backing out of her parking spot because there was a black Mercedes van next to Vehicle #1 obstructing his view. There was minor damage to the back right tail light.

Due to the statements made by both parties involved, I am unable to determine which driver is at fault.

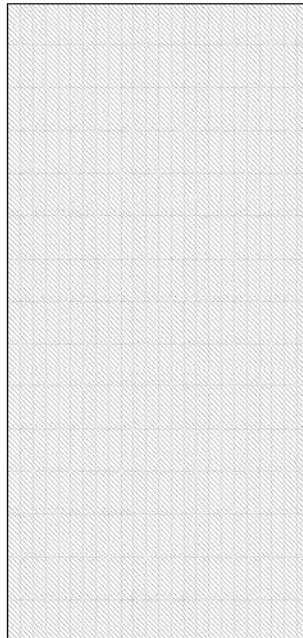

Motor Vehicle Crash Diagram

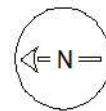
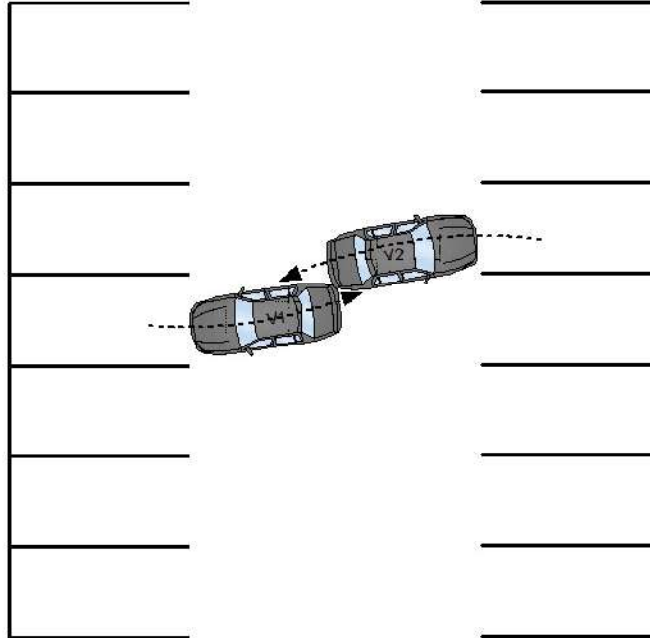
