145. Crash Description/Narrative

Vehicle 2 was stopped in the parking lot near 34 Kentwood Blvd. waiting for a separate vehicle to back from a parking stall. Vehicle 1 was backing from a parking stall in the same area. The crash occurred when vehicle 1 struck vehicle 2 as it was backing.

The driver of vehicle 1 stated she did not see anyone behind her when she was backing. The driver of vehicle 2 stated she had stopped to let a separate vehicle back when her vehicle was struck.

On scene I observed damage to the right lower rear of vehicle 1, and the right upper front of vehicle 2. The damage to vehicle 2 was on the passenger side of the vehicle and the passenger front door was unable to be fully opened.

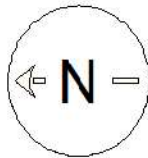
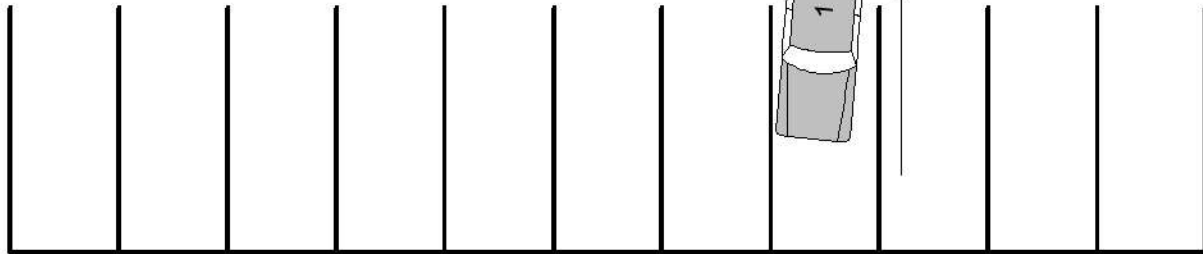
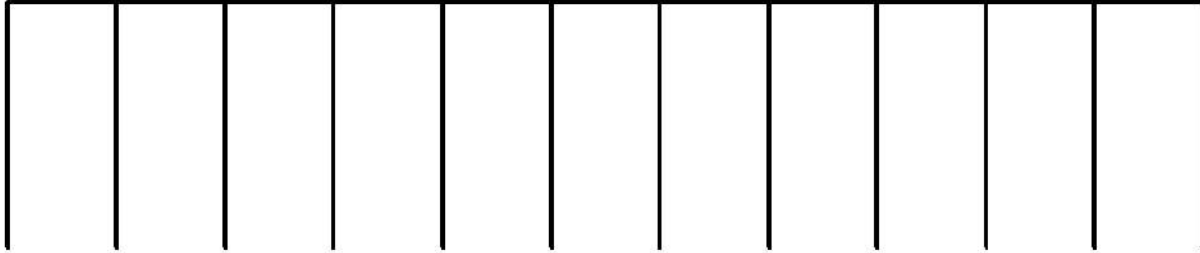
The driver of vehicle 1 was issued summons E17-7865 for careless driving for striking vehicle 2.
