145. Crash Description/Narrative

Vehicle 1 had pulled into a parking stall in the lot of WalMart and was backing in attempt to adjust his position in the parking stall. Vehicle 2 had backed from a parking stall and was preparing to drive away. The crash occurred when vehicle 2 struck vehicle 1 as it was backing.

The driver of vehicle 1 had advised he was attempting to straighten out his vehicle in the parking stall and did not see the vehicle behind him.

The driver of vehicle 2 stated she had already backed out of the her parking spot and was preparing to drive away when her vehicle was struck.

No injuries were reported. On scene I observed damage to the left lower rear of vehicle 1 and the left lower rear of vehicle 2. Vehicle 2 had damage on the rear drivers side tire as well.

The driver of vehicle 1 was issued summons E17-7870 for careless driving for striking vehicle 2 while he was

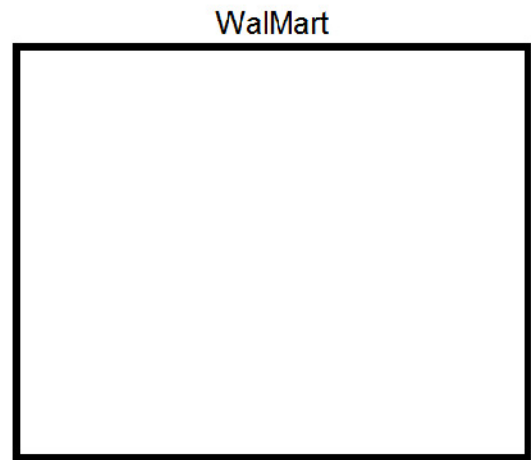
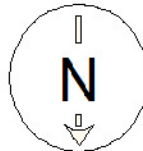
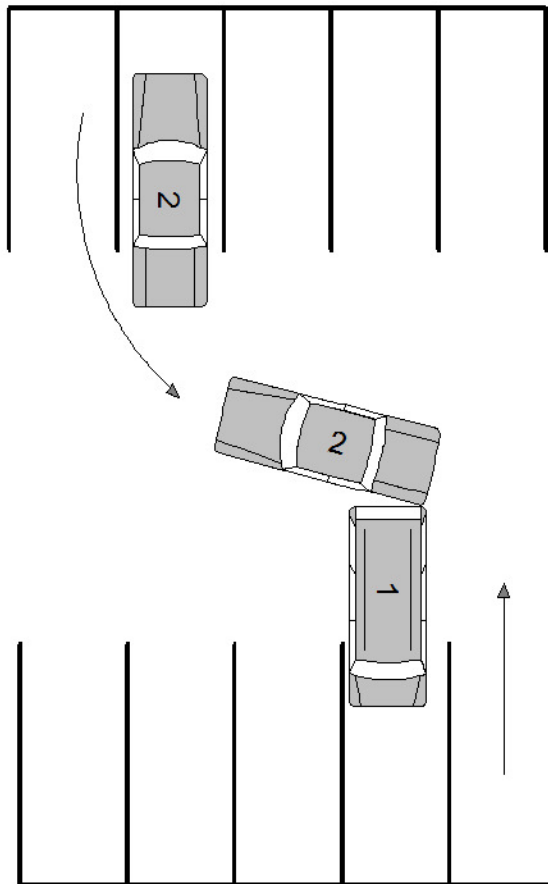
