145. Crash Description/Narrative

Vehicle 1 was backing out of a parking space in the parking lot of 1872 Rt. 88 when it collided with vehicle 2 who had already backed out of an opposite parking space and was stopped and preparing to move forward. Driver 1 stated that prior to backing out of the space, she checked behind her multiple times and upon seeing nothing, she proceeded to back up. She further stated that after backing up only "inches" out of the parking space, she heard a bang and realized she had struck vehicle 2. Driver 2 stated that she had fully backed out of the parking space, stopped, and while putting her vehicle in drive to move forward, she was struck in the rear bumper by vehicle 1. Driver 1 was found to be at fault for the crash as she failed to ensure there were no vehicles behind her prior to backing out of the parking space.

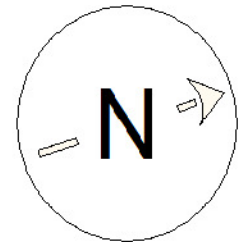
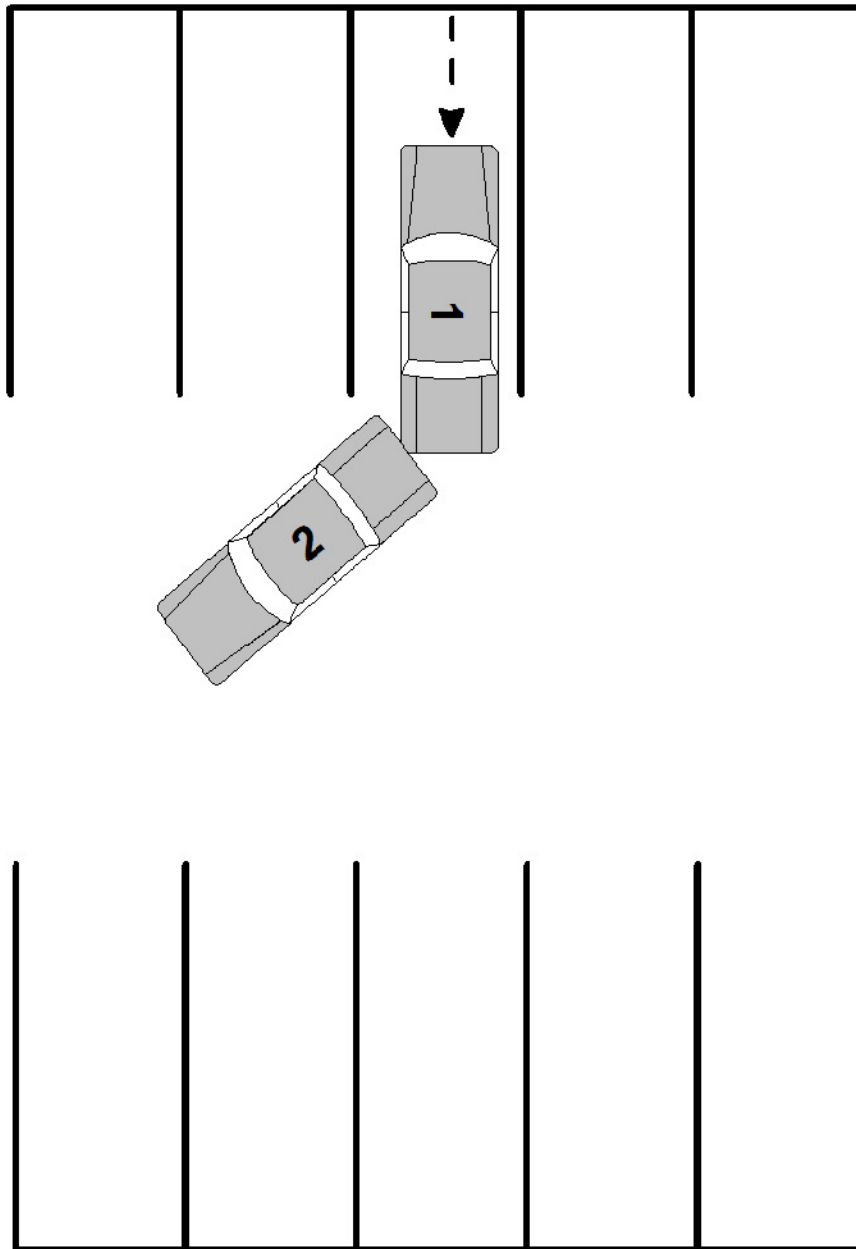
