145. Crash Description/Narrative

Investigation at the scene revealed the following: Vehicles # 1 and 2 were driving N/B on Church Rd going straight. Vehicle # 3 was stopped in traffic on Church Rd N/B. Vehicle # 2 was stopping in traffic and then Vehicle # 1's front driver's side bumper struck Vehicle # 2's rear passenger side bumper. Vehicle # 2 was then pushed forward and its front struck Vehicle # 3 rear. Vehicle # 2 came to rest on the opposite side of the road.

Driver of Vehicle # 1 stated "he was 3 car lengths behind the other car and then it hit its brakes hard coming to a quick stop. I tried to stop, but didn't have enough time, so I swerved to the right and still hit their bumper. Its the other driver's fault."

Driver of Vehicle # 2 stated "I was stopping in traffic and then the car behind me hit me in the back hard, pushing me into the car in front of me."

Driver of Vehicle # 3 stated "I was stopped in traffic and then my car was hit in the rear by the car behind me."

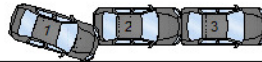
