145. Crash Description/Narrative

Vehicle #1 was towing a trailer, traveling North on Old Toms River Rd. stopped at the traffic light, near Beaverson Blvd in the right lane. Vehicle #2 was stopped in traffic directly behind Vehicle #1. Vehicle #1 began backing up, in attempt to get into the left lane to make a left hand turn onto Beaverson Blvd. While backing up, Vehicle #1's trailer struck the front end of Vehicle #2. No injuries were reported on scene, both vehicles moved prior to my arrival.

Driver #1 stated he was traveling North on Old Toms River Rd. stopped at the traffic light near Beaverson Blvd. when he realized he was in the wrong lane. Driver #1 further stated he began reversing his vehicle and trailer to get into the left lane, to make a left hand turn onto Beaverson Blvd. While backing up, his trailer struck the front end of Vehicle #2. Driver #1 admitted fault for backing his vehicle into Vehicle #2, trying to get into the other lane. I observed minor damage to the trailer.

Driver #2 stated he was directly behind Vehicle #1 and the trailer, in the right lane of Old Toms River Rd. when the trailer struck the front end of his vehicle. I observed substantial damage to the hood, grill and front bumper of Vehicle #2.
