145. Crash Description/Narrative

Vehicle 1 backing southbound out of a parking space in the parking lot of Walmart, 1872 Route 88. Vehicle 2 traveling westbound in the parking lot of Walmart, 1872 Route 88.

Driver 1 reported the following: Driver 1 was prepared to back up and saw Vehicle 2 approaching. Driver 1 waited and believed Vehicle 2 had completely passed when he began to back. As he backed out of the parking space, his driver's side rear struck the passenger side rear of Vehicle 2.

Driver 2 reported the following: Driver 1 was traveling through the parking lot when someone was removing a shopping cart from the cart corral in the parking lot. Driver 2 stopped for the unknown person. As he was waiting, his vehicle was struck by Vehicle 1 backing out of the parking space.

Driver 1 was found to be at fault for backing unsafely.

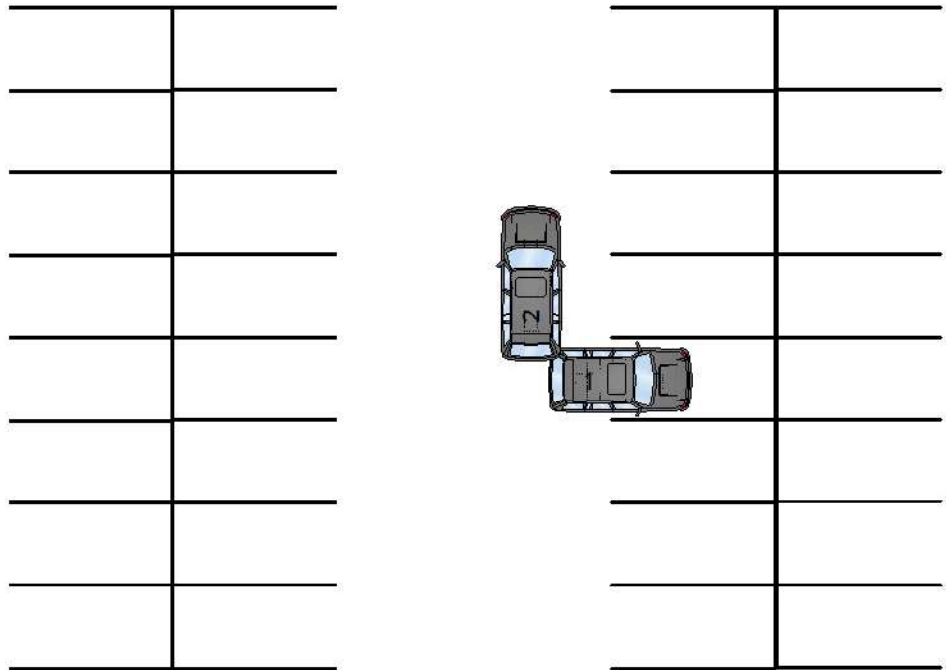
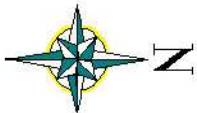
