145. Crash Description/Narrative

Vehicle one was traveling east in the Walmart parking lot. Vehicle two was traveling north in the Walmart parking lot on the outer perimeter road. Vehicle one came to a complete stop at a posted stop sign. Vehicle one continued to pull onto the outer perimeter road and struck vehicle two in the driver's side front quarter panel with the passenger side front bumper of vehicle one.

Upon speaking with driver one he was visibly agitated. Driver one advised that he stopped at the stop sign and pulled out onto the perimeter road when vehicle two struck his vehicle. Driver two advised that he was traveling north on the perimeter road when vehicle one struck his vehicle. Both drivers advised they are not injured and refused medical attention.

Vehicle one sustained damage to the passenger side headlight assembly and a dent in the front bumper. Vehicle two sustained damage to the driver's side headlight assembly, front driver's side quarter panel, driver's side front wheel well and a dent to the front bumper.

Based upon the statements of both drivers and the nature of the damage to both vehicles I determined that driver

one is at fault. Driver one was specifically at fault since he was required to stop at the posted stop sign and yield to vehicle two. Driver one was issued summons E21-003775 for a violation of 39:4-144 (failure to stop or yield).

The damage to both vehicles did not appear to impede the ability to operate the vehicles safely. Both vehicles were driven from the scene.

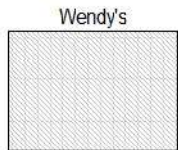

144 Crash Diagram (NOT TO SCALE)

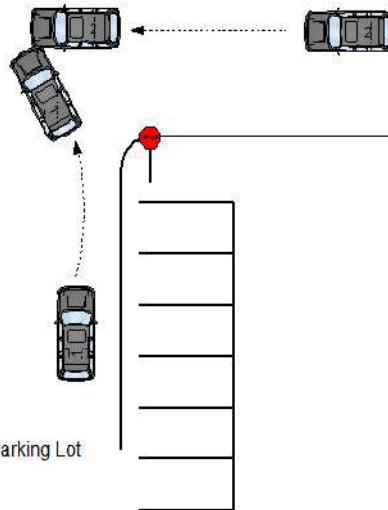
