145. Crash Description/Narrative

Vehicle 1 was backing out of a parking space in the parking lot of Walmart, 1822 Route 88. Vehicle 2 was traveling

in the lane Vehicle 1 was backing into. Driver 1 did not see Vehicle 2 resulting in Vehicle 1 impacting the front

bumper of Vehicle 2 with it's rear bumper.

Driver 1 advised he did not notice Vehicle 2 approaching him.

Driver 2 advised he saw Vehicle 1 backing towards him and could not avoid the impact.

No injuries were reported on scene.

My investigation revealed Driver 1 is at fault for the crash. Vehicle 2 had the right of way and did not have

anywhere to go to avoid the crash.

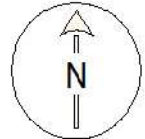
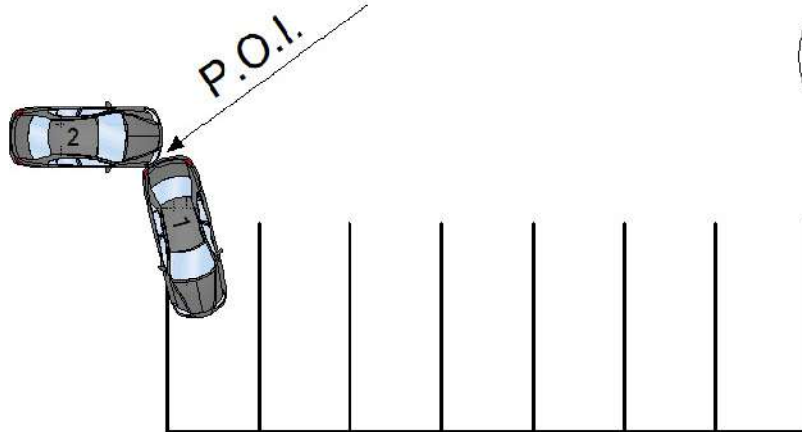
