145. Crash Description/Narrative

Crash investigation reveals a two vehicle crash in the parking lot of the Home Depot store, 1722 Route 88 in Brick, NJ. The driver of vehicle 2 stated she was traveling east through the Home Depot store parking lot going straight ahead. As vehicle 2 was traveling east through said parking lot, the driver of vehicle 2 stated vehicle 1 began backing out of a marked parking spot as she was passing vehicle 1's marked parking spot.

As a result of vehicle 1 backing out of a marked parking spot when vehicle 2 was passing the parking spot where vehicle 1 was backing out of, the right middle side of vehicle 2 crashed into the rear of vehicle 1. The driver of vehicle 1 stated he was backing out of a marked parking spot in said parking lot traveling north.

As vehicle 1 was backing out of the marked parking spot, the driver of vehicle 1 stated vehicle 2 crashed into the rear of his vehicle. Based on the location of the crash, as well as, where both vehicles sustained damage, it's evident that the driver of vehicle 2 had the right of way while traveling east through said parking lot while the driver of vehicle 1 didn't have the right of way.

No injuries were reported. Both vehicles sustained damage and were driven from the scene. The driver of vehicle 1

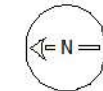
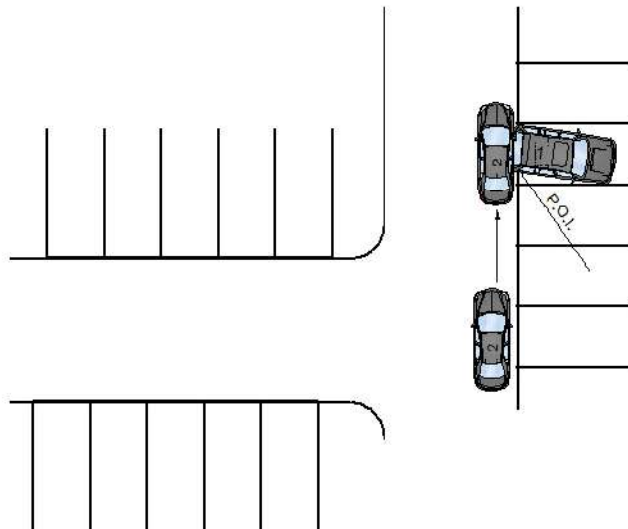
