145. Crash Description/Narrative

A motor vehicle crash occurred at 1872 Route 88 (Wal Mart).

Driver of Vehicle #1 advised he was waiting to turn left onto Jack Martin Blvd from Wal Mart. Driver #1 stated the vehicle in front of him began to move. Driver #1 began to move forward and observed Vehicle #2 stopped and struck the rear of Vehicle #2.

There was minor damage to the front driver side bumper of Vehicle #1.

Driver of Vehicle #2 advised she was stopped at the stop sign, waiting to turn left onto Jack Martin Blvd from Wal Mart. Driver #2 advised she was struck from behind by Vehicle #1 while she was stopped at the stop sign.

There was moderate damage to the rear driver side bumper of Vehicle #2.

There were no reported injuries while on scene.

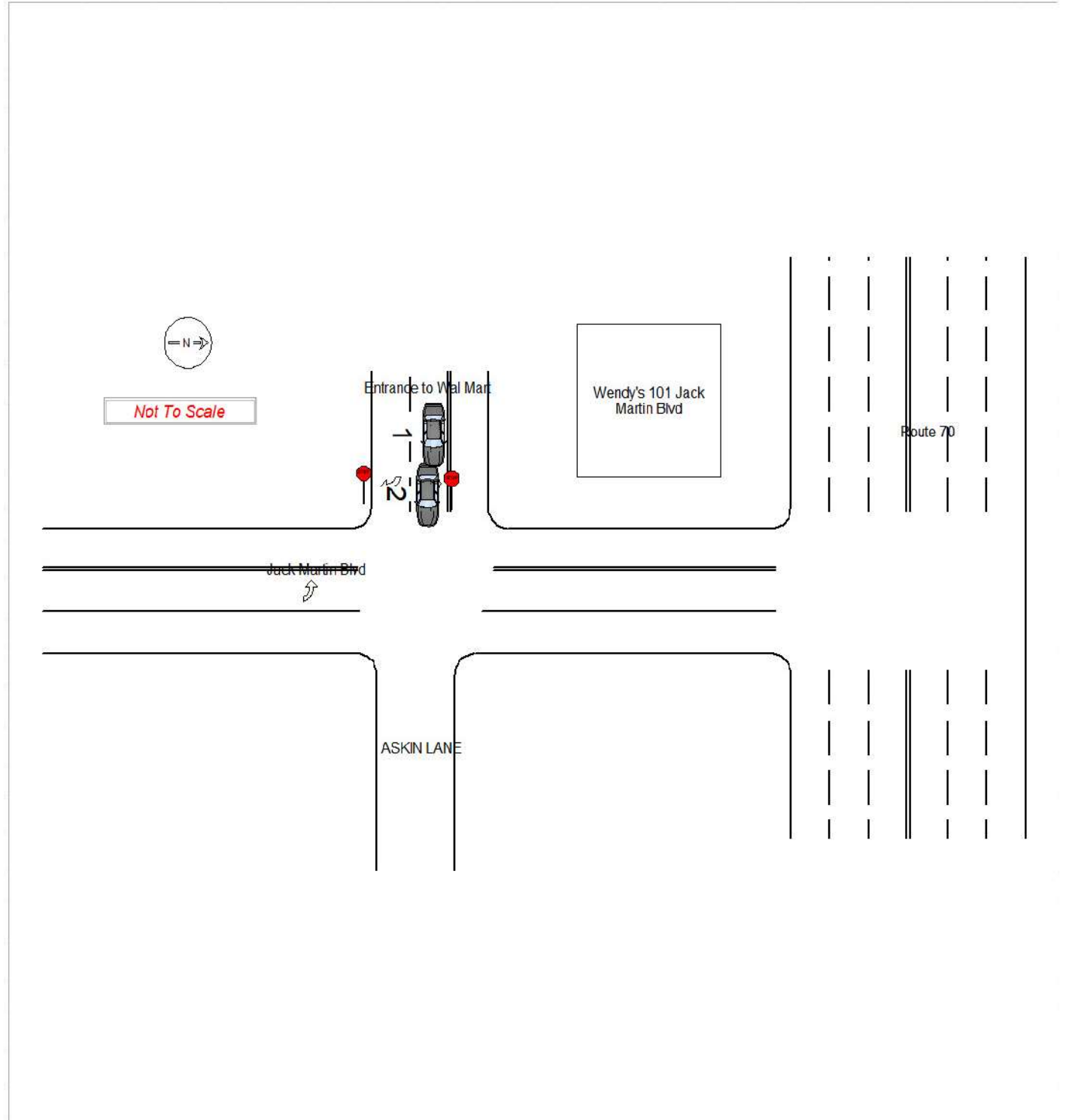
