145. Crash Description/Narrative

Investigation at the scene indicated the following: Vehicle 2 faced west while stopped in traffic on Route 88 at the intersection with Fort Street. Vehicle 1 traveled west on Route 88 and struck the rear of vehicle 2 with the front of the vehicle. Debris in the roadway indicated that the accident occurred at the intersection of Route 88 and Fort Street.

Driver 1's statement:

She was the second vehicle behind vehicle 2 as they traveled west on Route 88. The vehicle directly in front of her drove onto the right shoulder of the roadway. She did not see vehicle 2 stopped in time to avoid the collision and the front of her vehicle struck the rear of vehicle 2.

Driver 2's statement:

He was stopped in traffic on Route 88 near the intersection with Edge Street and the rear of his vehicle was struck by another.

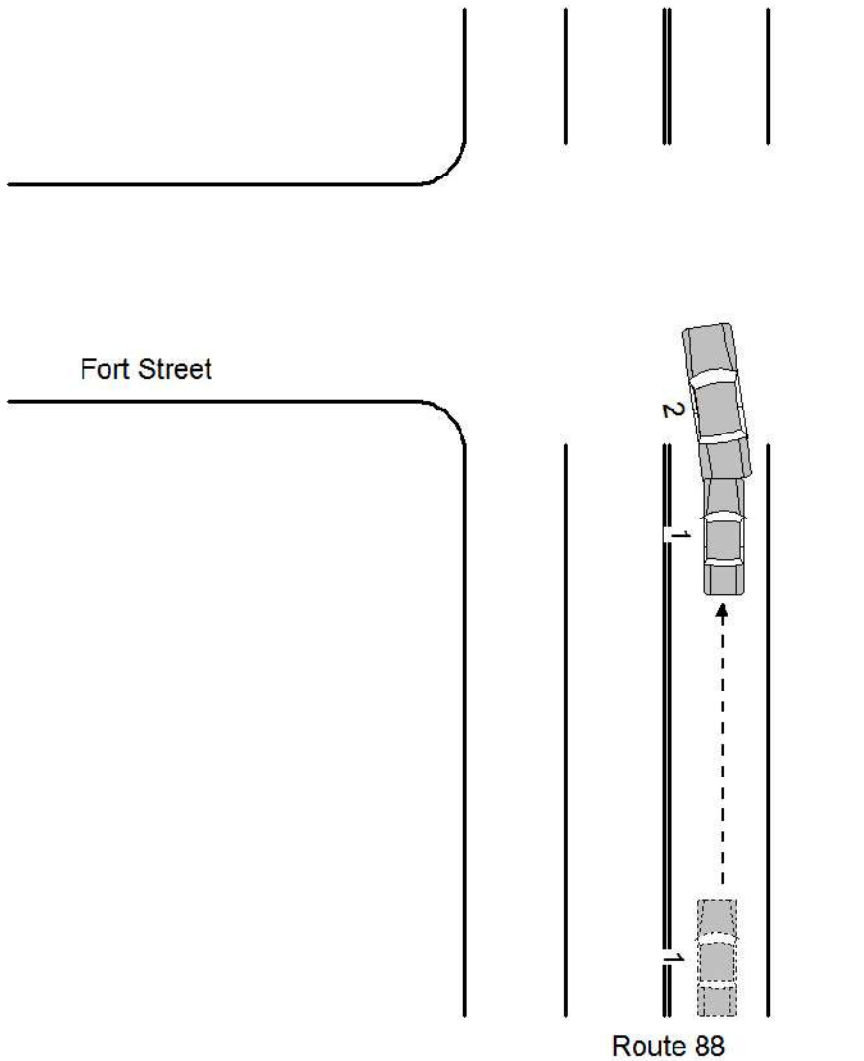
