145. Crash Description/Narrative

Vehicle #1 collided with Vehicle #2 in a right angle crash on RT 88 in the westbound lane.

Driver of Vehicle #1 stated she was traveling eastbound on RT 88 and attempted to make a left turn into the RT 88 entrance for Ocean Medical Center. Driver #1 stated as she turned her vehicle was struck along right side near the back of the vehicle by Vehicle #1. Vehicle #1 sustained moderate damage to the right side near the right rear tire.

Driver of Vehicle #2 stated she was traveling straight ahead westbound on RT 88. Driver #2 stated an unknown vehicle traveling eastbound on RT 88 made a left into Ocean Medical Center entrance. Driver #2 stated Vehicle #1 followed closely behind that vehicle and turned in front of her. Driver #2 stated she attempted to utilize her breaks to avoid the crash but was unsuccessful.

Based on my observations and statements made by both parties I found the driver of Vehicle #1 at fault for failing to yield right of way to vehicle #2.

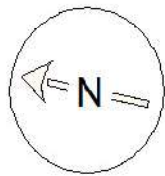

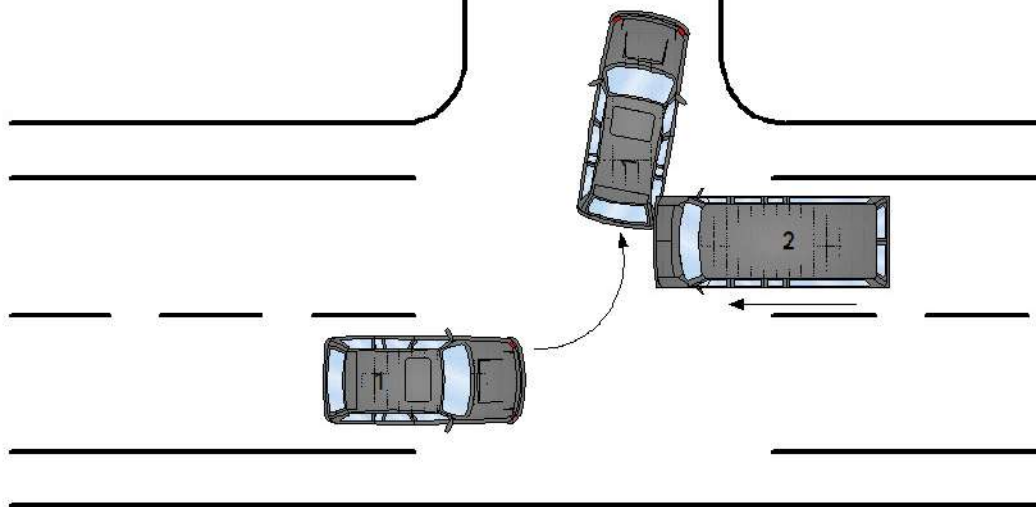
