145. Crash Description/Narrative

Driver of vehicle #1 was traveling West on Rt. 88 directly behind vehicle #2. Vehicle #2 stopped short due to an unknown vehicle who stopped to make a left turn onto Fort St. Vehicle #1 struck vehicle #2 as both vehicles were attempting to stop.

Driver of vehicle #1 stated a vehicle in front of vehicle #2 stopped short. As vehicle #2 began to stop he entered the shoulder as did driver #1. Driver #1 struck the rear right bumper of vehicle #2.

Driver of vehicle #2 stated a vehicle in front of him stopped short causing him to swerve around him onto the shoulder to avoid the collision. He stated he looked in his rear view mirror and saw vehicle #1 extremely close to his vehicle which subsequently rear ended him.

My investigation revealed driver of vehicle #1 was following too closely behind vehicle #2 and was unable to stop in time to avoid the crash.

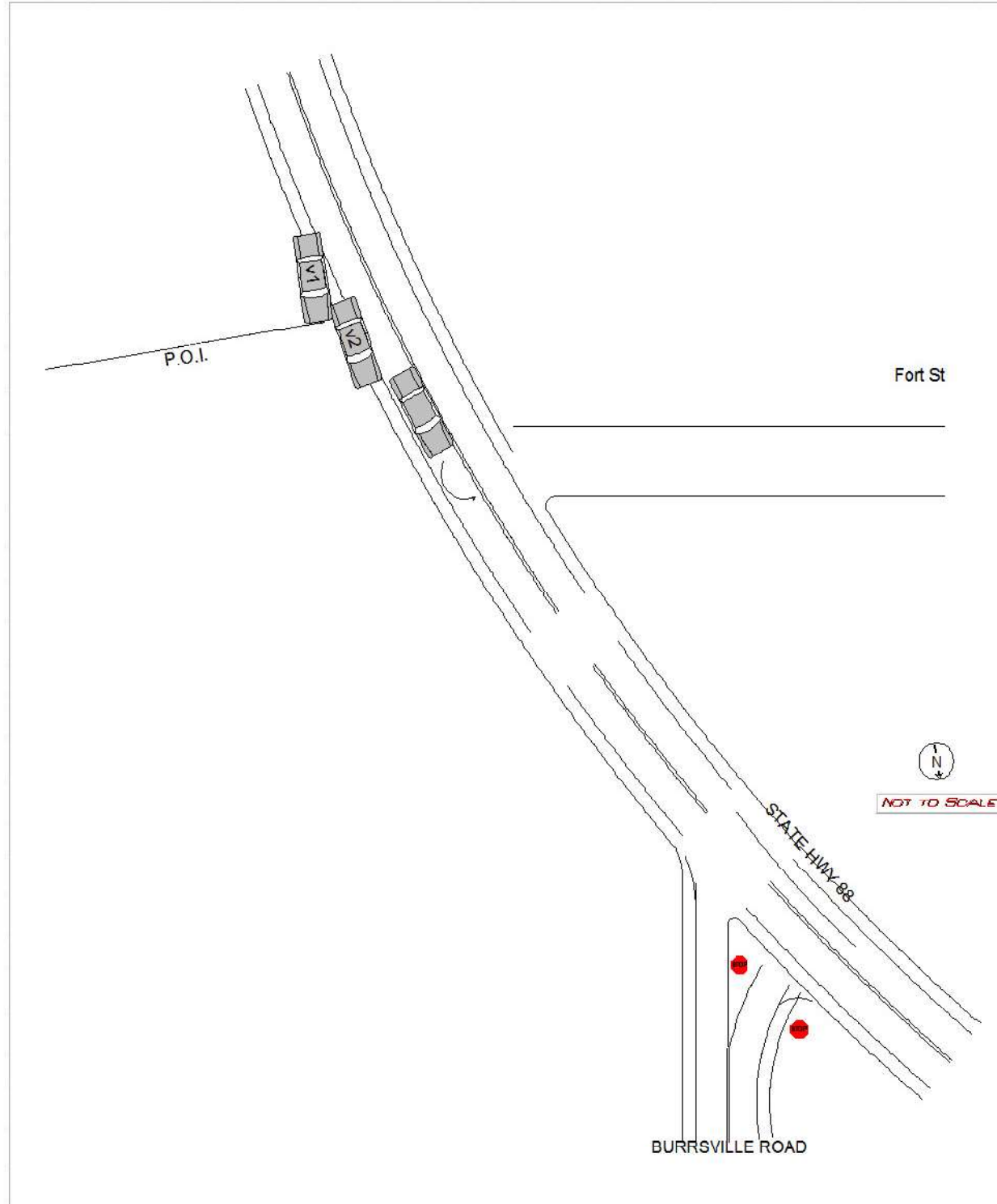
