135 Crash Description

Vehicle 2 was traveling west on Route 88 approaching Fort Street. Vehicle 1 was traveling west on Route 88 behind vehicle 2. Vehicle 3 was traveling east on route 88 approaching Fort Street. Vehicle 2 slowed down as he prepared to make a left turn onto Fort Street. Vehicle 1 struck the rear bumper area of vehicle 2 with the front bumper area of her vehicle. Vehicle 2 struck the front left bumper area of vehicle 3 with the front left bumper area of his vehicle. I observed minor damage to vehicle 3 which was driven from the scene. I observed significant damage to vehicle 1 which had front air bag deployment and vehicle 2 which did not.

Vehicle 1 was removed by Joe's and Son's Towing. Vehicle 2 was removed by Lepores Towing. The passenger in vehicle 2 had complaints of back pain but refused medical attention. All other parties were offered medical attention which they refused. I observed no injuries and none were reported.

Driver 1 stated she was traveling west on Route 88. Driver 1 further stated she saw vehicle 2 in front of her but did not see any brake lights or turn signals. Driver 1 stated she attempted stop but was unable to do so before striking the rear bumper area of vehicle 2 with the front bumper area of her vehicle.

Driver 2 stated he was traveling west on Route 88 stopped at the intersection with Fort Street. Driver 2 further stated he had his left hand turn signal on. Driver 2 advised vehicle 1 struck the rear bumper area of his vehicle with the front bumper area of her vehicle.

Driver 3 stated he was traveling east on Route 88 approaching Fortt Street. Driver 3 further stated he observed vehicle 1 collide with the vehicle 2 causing vehicle 2 to crossover into his lane of travel. Driver 3 advised he attempted to avoid the collision by crossing over into the west bound lane but vehicle 2 struck the front left bumper area of his vehicle with the front left bumper area of vehicle 2.

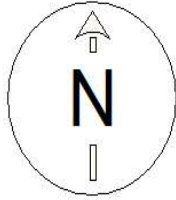
