Vehicle 1 stopped at the stop sign for the exit of 1608 Route 88, attempting a left turn onto Route 88 eastbound. Vehicle 2 stopped at the stop sign on Fort Street at Route 88, attempting a right turn onto Route 88 eastbound.

Driver 2 stated he was stopped and checking for traffic. Driver 2 stated when it was clear, he began his right turn and was on Route 88 when he was struck by Vehicle 1.

Driver 1 stated he was stopped at the stop sign, checking for oncoming traffic. Driver 1 stated he saw no traffic coming and began to make his left turn. Driver 1 stated he did not see Vehicle 2 as he was pulling out.
