135 Crash Description

The driver of vehicle #3 stated she was traveling north on Rt. 88, near the intersection with Fort St.. She stated vehicle #1 turned left from the parking lot of 1608 Rt. 88, on to Rt. 88 southbound, directly in front of her. She stated vehicle #1 struck vehicle #2, which was traveling south on Rt. 88, and then spun around and struck the driver side of her vehicle.

The driver of vehicle #2 stated he was traveling southbound on Rt. 88 near Fort St. when vehicle #1 attempted to turn out of a parking lot and directly in front of him. He stated he could not avoid vehicle #1 and was struck on the front driver side bumper.

The driver of vehicle #1 stated she was attempting to turn left out of the parking lot at 1608 Rt. 88. She stated she never observed vehicle #2 and turned directly in front of him. She stated that by the time she saw vehicle #2, it was too late to avoid him. After she struck vehicle #2, she stated she spun around and struck vehicle #3 traveling north on Rt. 88.

Moderate damage to all three vehicles. The driver of vehicle #2 was transported to Ocean Medical Center with a finger injury.

The driver of vehicle #1 was issued a summons for careless driving, 39:4-97, on summons # T151597.
