135 Crash Description

Vehicle #2 was stopped in traffic on Route 88(Eastbound), just prior to Fort Street, waiting for traffic to clear to make a left into the Brick Professional Complex (1608 Route 88). Vehicle #1 was traveling on Route 88 (Eastbound), failed to observe Vehicle #2 stopped in front of him, and struck Vehicle #2 in the rear.

Vehicle #1 driver stated he was traveling on Route 88 (Eastbound), when an ambulance with its lights on, who was traveling on Route 88 (Westbound), turned into the Route 88 entrance of Brick Hospital (425 Jack Martin Boulevard). Vehicle #1 driver stated the lights on the ambulance must have distracted him, causing him not to notice Vehicle #2 stopped in front of him. Vehicle #1 driver stated he attempted to stop, but could not avoid striking the rear of Vehicle #2.

Motor Vehicle Crash Diagram

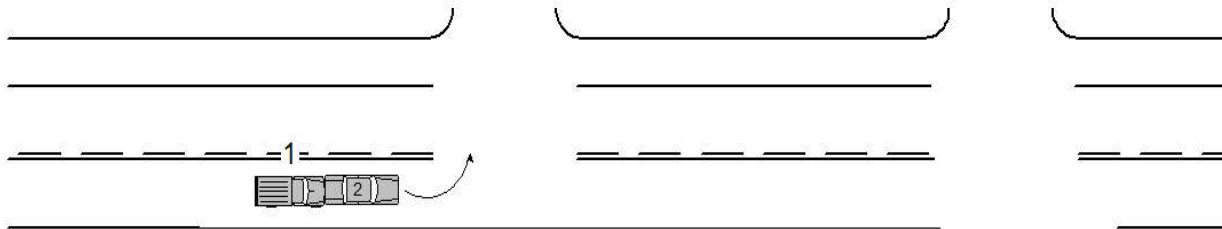
