145. Crash Description/Narrative

The driver of vehicle #2 stated she was traveling west on Rt. 88, just west of Jack Martin Blvd. when vehicle #1 made a left turn directly in front of her. She stated vehicle #1 exited a parking lot and struck her front driver side bumper.

The driver of vehicle #1 stated she was turning left out of a parking lot on to Rt. 88 westbound. She stated she never observed vehicle #2 and turned directly in front of her. As a result she struck the front driver side bumper of vehicle #2 with the front passenger side bumper of her vehicle.

No injuries reported. Moderate damage to both vehicles.

Based on both of the driver's statements as well as observing the damage to both vehicles, it is my determination that vehicle #1 caused the crash by failing to observe vehicle #2 and turning directly in front of her.

The driver of vehicle #1 received a summons for driving an unregistered vehicle on summons # T164806.

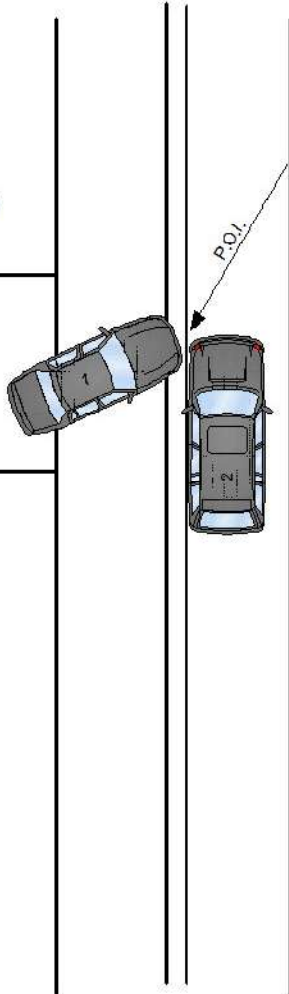

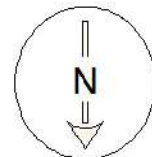
