145. Crash Description/Narrative

Vehicle 1 stopped on Jack Martin Boulevard northbound, waiting to turn left into the parking lot of Walmart.

1872 Route 88. Vehicle 2 traveling southbound on Jack Martin Boulevard, approaching the entrance to Walmart.

Driver 1 stated she was waiting to turn left into the parking lot of Walmart. An unknown vehicle in the southbound right turn lane came to a stop at the intersection of the entrance. Driver 1 was unsure of what the unknown vehicle was doing. Believing it was stopped to let her go, Driver 1 began to make her left turn into the parking lot. As she was making her turn, Driver 1 then felt the impact of Vehicle 2 striking her vehicle.

Driver 1 stated she never saw Vehicle 2.

Driver 2 stated she was traveling southbound on Jack Martin Boulevard, approaching the entrance to Walmart.

Driver 2 stated Vehicle 1 turned directly in front of her and she struck the passenger side rear of Vehicle 1 with the passenger side front of her vehicle.

Driver 1 was found to be at fault for an improper left turn and failing to see Vehicle 2 approaching.

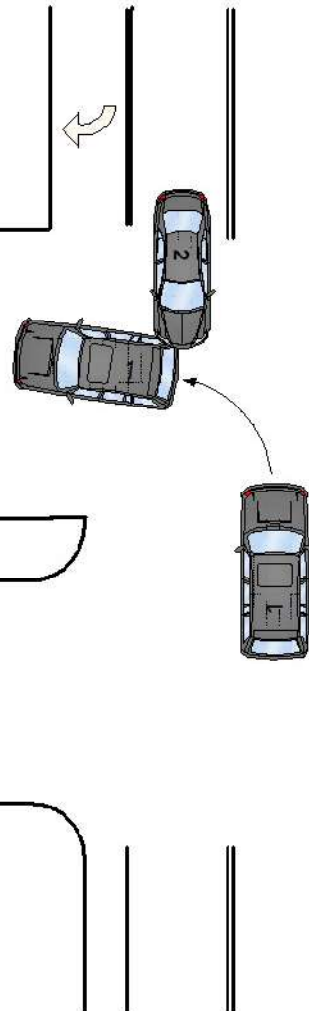
