145. Crash Description/Narrative

Vehicle 1 was traveling south on Burrsville Road approximately 20 feet north of Route 88. Vehicle 2 was directly in front of Vehicle 1. Vehicle 2 was stopping at the stop sign on Burrsville Road when Vehicle 1 struck the rear left side of Vehicle 2's bumper.

In speaking with the driver of Vehicle 1, he stated Vehicle 2 was stopped in front of him at the stop sign on Burrsville Road and then began to go. Driver 1 stated he did not realize Vehicle 2 had quickly stopped and had not turned onto Route 88, at which point Vehicle 1's front passenger side bumper struck the rear driver side bumper of Vehicle 2.

In speaking with the driver of Vehicle 2, he stated he had pulled up to the stop sign and looked both ways before going. As driver 2 began to pull out he saw a vehicle coming on Route 88 and had to quickly stop. Driver 2 stated at this time is when Vehicle 1 which was directly behind him struck the rear of his vehicle.

Neither party was injured and refused medical attention, the driver of Vehicle 1 was given a summons for careless driving (E21-0001252).

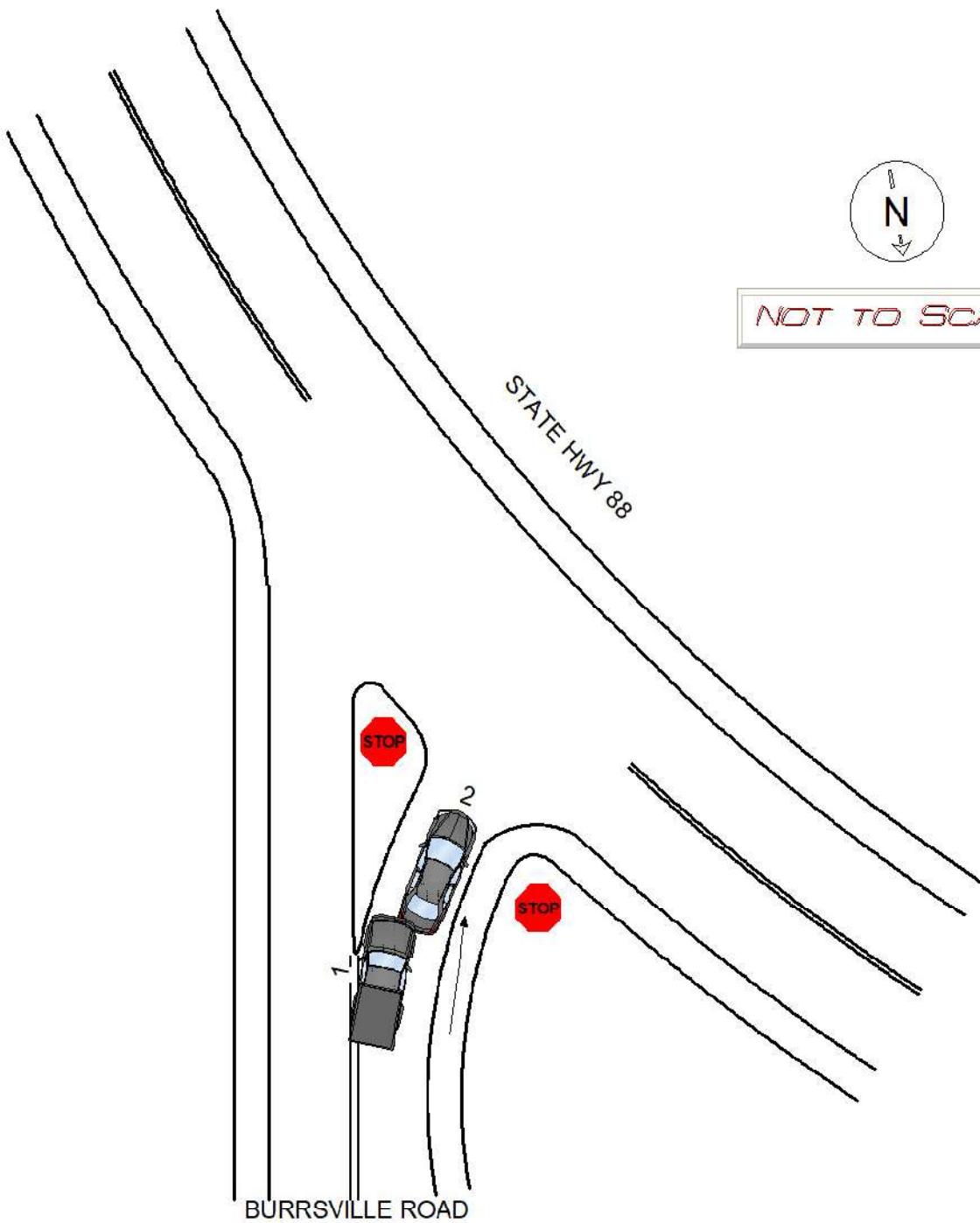
