145. Crash Description/Narrative

Vehicle #2 was stopped at the red traffic signal. Vehicle #1 was attempting to brake, but was unable to stop prior to crashing into the rear of vehicle #2.

The driver of vehicle #1 stated she was attempting to stop the vehicle by utilizing her brake pedal, but the brakes continued to the floor. Subsequently the vehicle was unable to stop and crashed into the rear of vehicle #2.

The driver of vehicle #2 stated she was stopped at the red traffic signal, when a she felt a thump into the rear of her vehicle.

Neither driver sustained any injuries.

While in the parking lot the driver of vehicle #1 pumped the brakes and the vehicle began to get brake pedal back. I instructed the driver of vehicle #1 to park her vehicle in the lot, until she could have someone inspect the brakes furtheror get the vehicle towed from the scene.

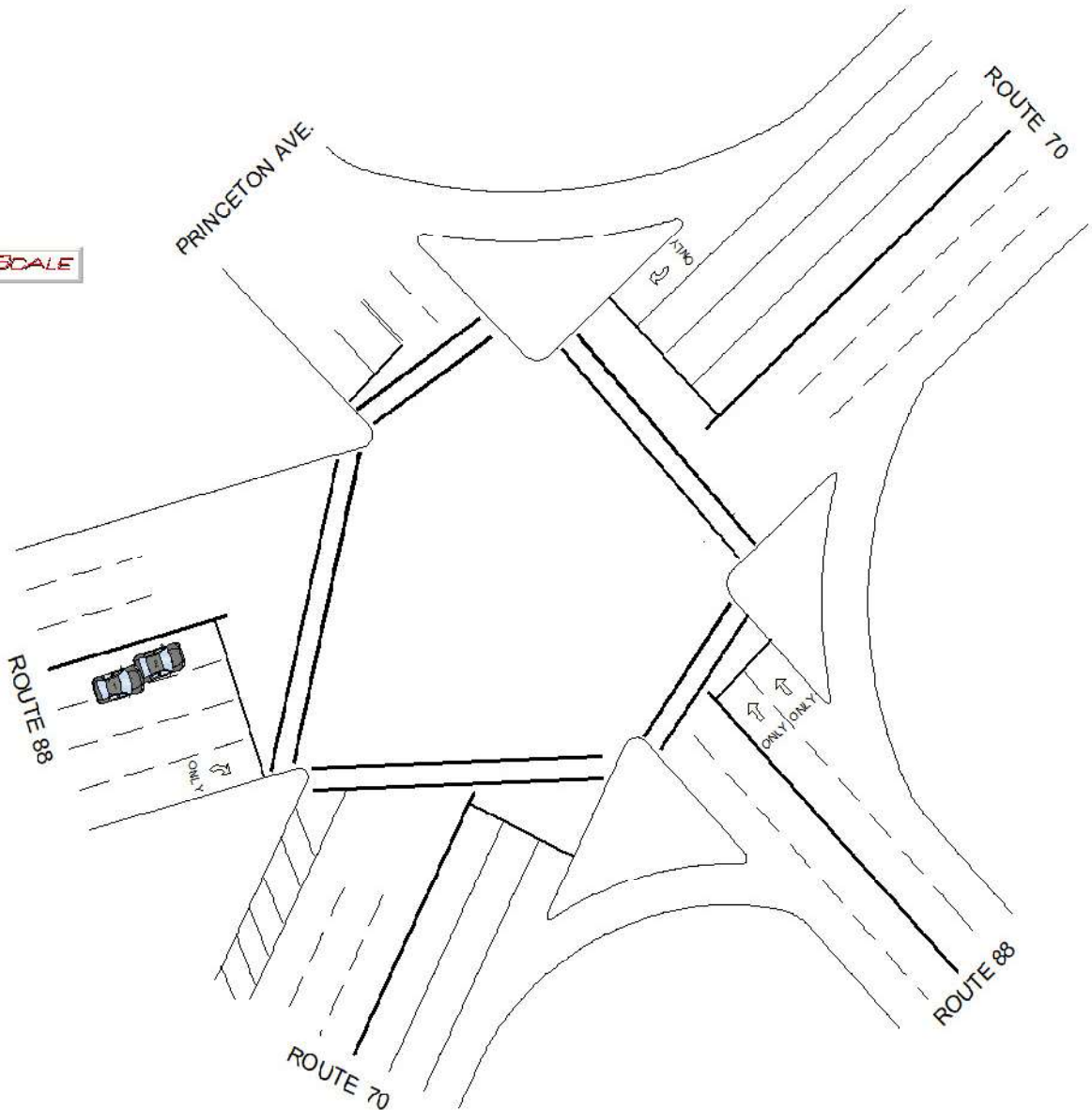
