145. Crash Description/Narrative

Vehicle 1 was attempting to make a left hand turn from the parking lot of 1904 Rt. 88 to Rt. 88 west bound when it struck vehicle 2 who was traveling east bound on Rt. 88. After the impact, vehicle 1 was spun around causing it to travel back toward the parking lot of 1905 Rt. 88 and come to rest against a utility pole, #JC5552BK. After impact, vehicle 2 traveled across the west bound lane, off the roadway and collide with a curb on the west bound side of the road where it came to rest.

Driver 2 stated that while traveling east on Rt. 88, vehicle 1 exited a parking lot and collided with her vehicle and causing her to travel across the road and strike the curb. Driver 1 stated that when she initially came to the exit, she looked both ways for traffic and did not see any east bound vehicles but had heavy traffic traveling west bound. While waiting for an opportunity to exit the lot and turn left onto west bound on Rt. 88, a west bound vehicle stopped and waved for her to pull out of the lot. She did not recall checking for east bound traffic a second time before exiting the lot. Driver 1 did not recall the impact as she had lost consciousness during the impact. Several witnesses stated that they observed vehicle 1 just pull out of the parking lot and collide with vehicle 2. Both vehicles sustained heavy damage and were towed from the scene. Driver 1 sustained injury to the left ankle and head, the front passenger in vehicle 1 sustained a minor leg injury and both were

transported to the hospital by ambulance. Driver 2 had a complaint of pain to the lower leg but refused further medical treatment at this time.

The resulting investigation found that driver 1 was at fault for the crash as she had not properly checked for approaching east bound traffic before entering Rt. 88 from the parking lot and was issued a summons, #T157260, for Careless Driving 39:4-97.

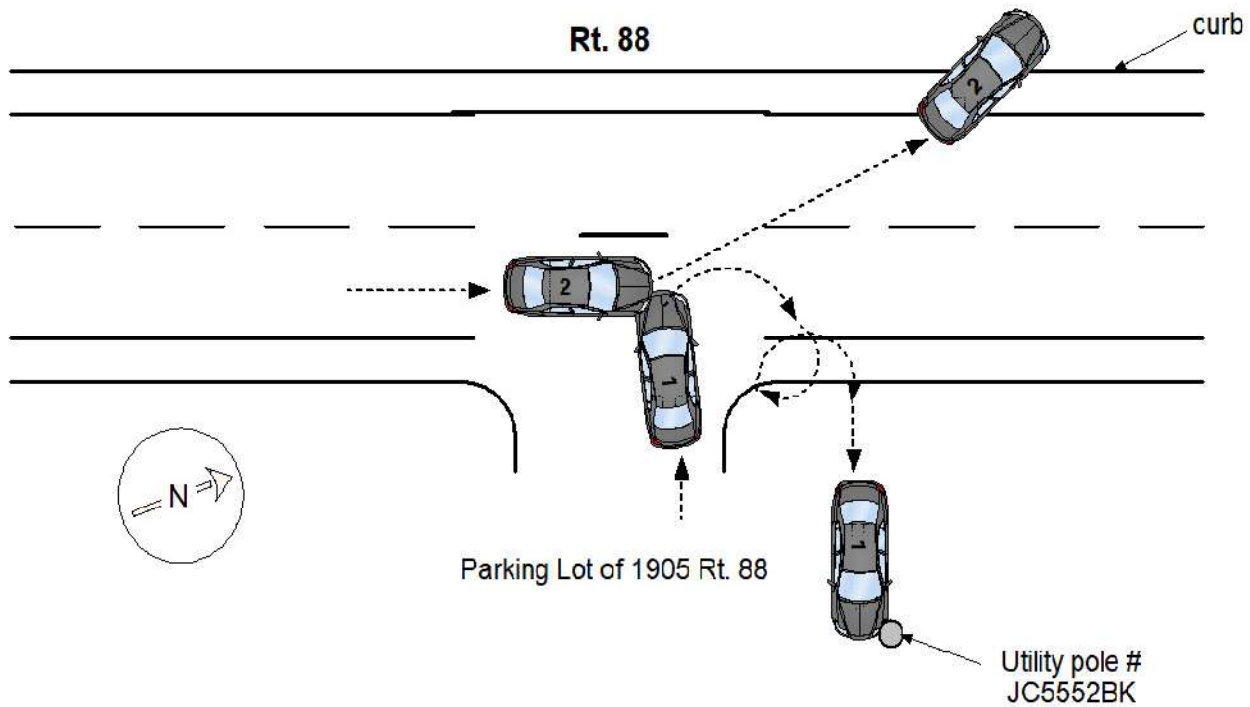
