145. Crash Description/Narrative

Crash investigation reveals a two vehicle, same direction, rear end crash on Route 88 W near the intersection of

Route 88 W/Post Road. The driver of vehicle 1 stated he was traveling on Route 88 W in the right lane approaching

Post Road. As vehicle 1 got closer towards Post Road, the driver of vehicle 1 stated he was joking and messing

around with his front seat passenger after he had changed said lanes. As a result of being distracted by the

front seat passenger, the driver of vehicle 1 stated he wasn't paying attention to the roadway in front of him.

At that time, the driver of vehicle 1 stated he observed vehicle 2 stopped in the left lane directly in front of

him.

The driver of vehicle 1 stated he was unable to stop in time which caused the front of vehicle 1 to crash into the

rear of vehicle 2. The driver of vehicle 2 stated she was stopped in the left lane on Route 88 W near the

intersection of Route 88 W/Post Road. While vehicle 2 was stopped for traffic in front of her, the driver of

vehicle 2 stated she observed vehicle 1 in her rear view mirror driving directly towards the rear of her vehicle

at a high rate of speed. At that time, the driver of vehicle 2 stated she knew based on the speed and close

distance of vehicle 1 to her vehicle that vehicle 1 was going to crash into the rear of her vehicle which

subsequently was the end result.

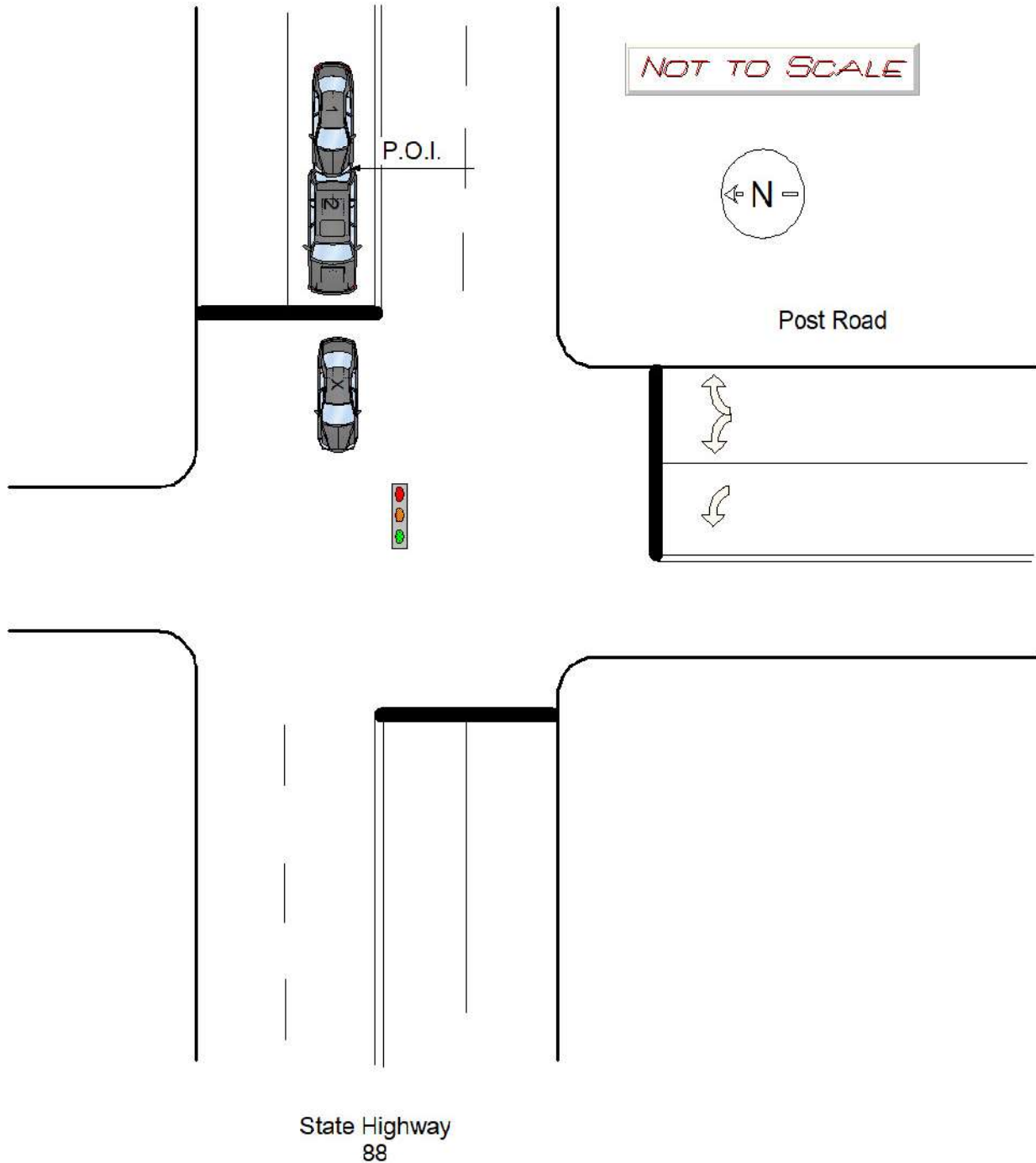
