145. Crash Description/Narrative

The driver of vehicle #2 stated she was on the off ramp from Rt. 88 west on to Rt. 70 west. She stated she was stopped at the yield sign, waiting for traffic to clear on Rt. 70, when vehicle #1 struck her from behind.

The driver of vehicle #1 stated he was directly behind vehicle #2. He stated he was looking back towards the traffic on Rt. 70 and thought vehicle #2 moved forward. He started to move forward and did not realize vehicle #2 was still stopped. As a result he struck the rear of vehicle #2.

Minor damage to both vehicles. No injuries reported.

Based on both of the driver's statements as well as observing the damage to both vehicles, it is my determination that vehicle #1 caused the crash by driving carelessly and failing to observe vehicle #2 stopped in traffic directly in front of him.

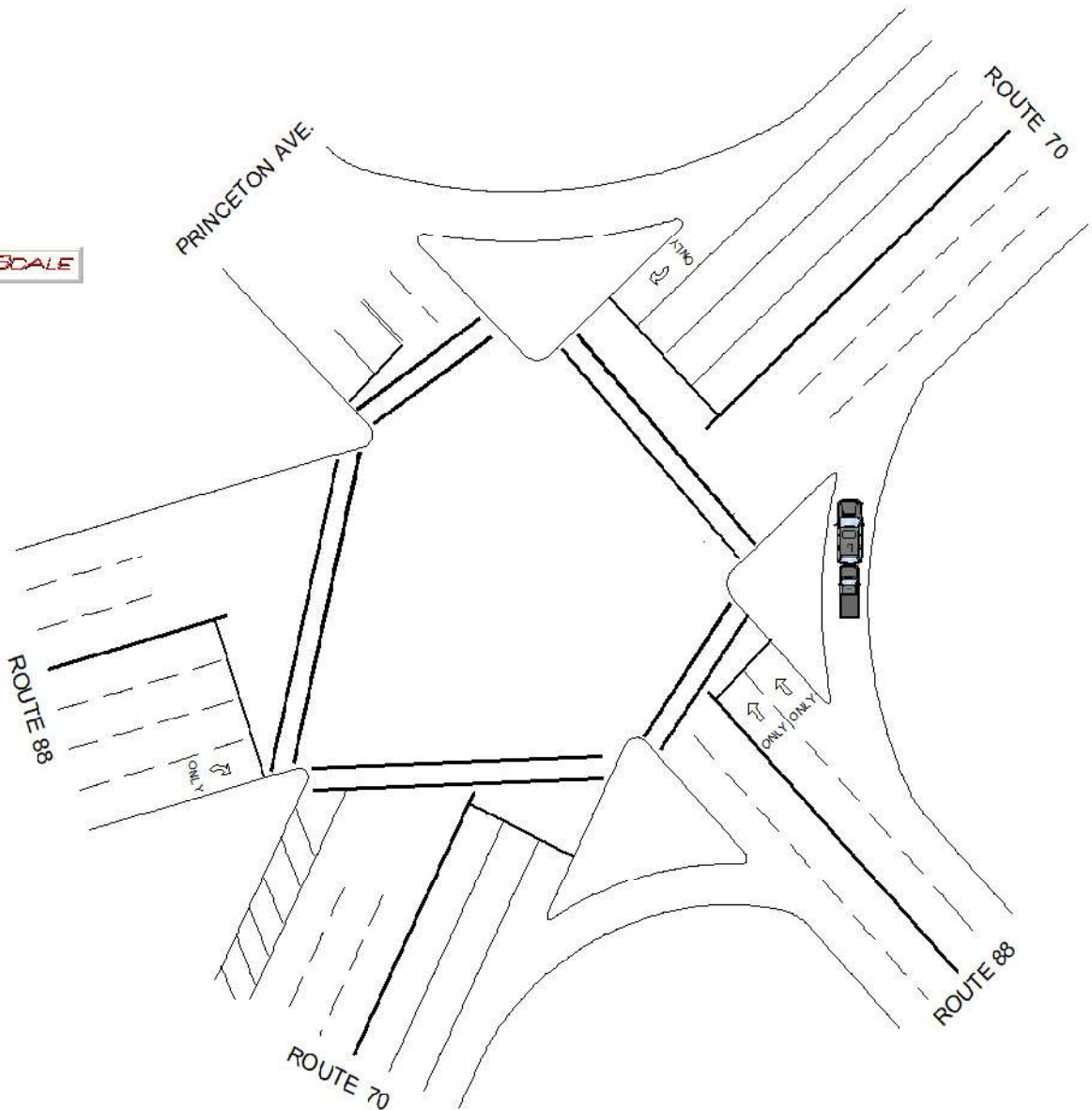
