145. Crash Description/Narrative

There was a motor vehicle crash that occurred at the intersection of Route 88 and Olden Street.

Driver 1 stated that they were turning left onto Route 88 from the light at Olden Street. When making the left turn they were struck by Vehicle 2.

Driver 2 stated that they were going straight on Olden Street approaching the intersection of Route 88 when Vehicle 1 entered their path of travel causing the collision.

Vehicle 1 had moderate damage to the front passenger side. Vehicle 1 was removed from the scene by the owner.

Vehicle 2 had moderate damage to the front grill area. Vehicle 2 front airbags deployed during the collision. Vehicle 2 was towed by a private tow (AAA).

Driver 2 had complaint of pain in his left wrist. Brick Township Police EMS responded to the scene where Driver 2 refused further medical treatment.

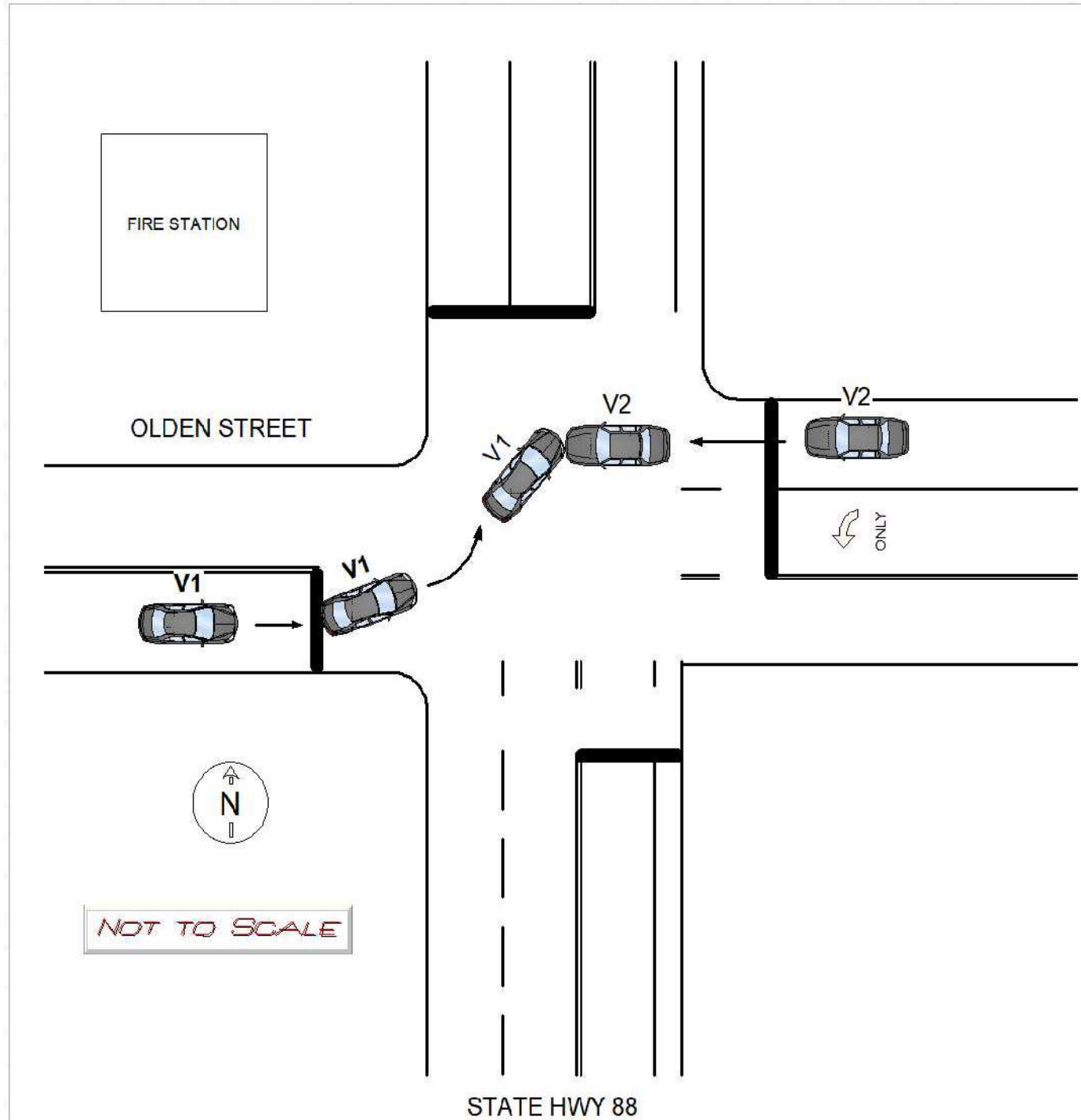
