145. Crash Description/Narrative

Vehicle 1 was traveling eastbound in the right lane on Rt. 70 approaching the ramp to Olden St. Vehicle 2 was directly ahead of Vehicle 1.

Vehicle 2 was slowing in traffic on the ramp when Vehicle 1 struck the rear of Vehicle 2.

Driver 1 stated he was slowing behind Vehicle 2 but believed it had moved forward, as there was heavy traffic, but instead struck the rear of Vehicle 2. Driver 2 stated he was slowing in traffic when Vehicle 1 struck the rear of his vehicle.

Vehicle 2 sustained minor damage to the rear. Vehicle 1 sustained no damage.

Both vehicles were moved prior to my arrival.

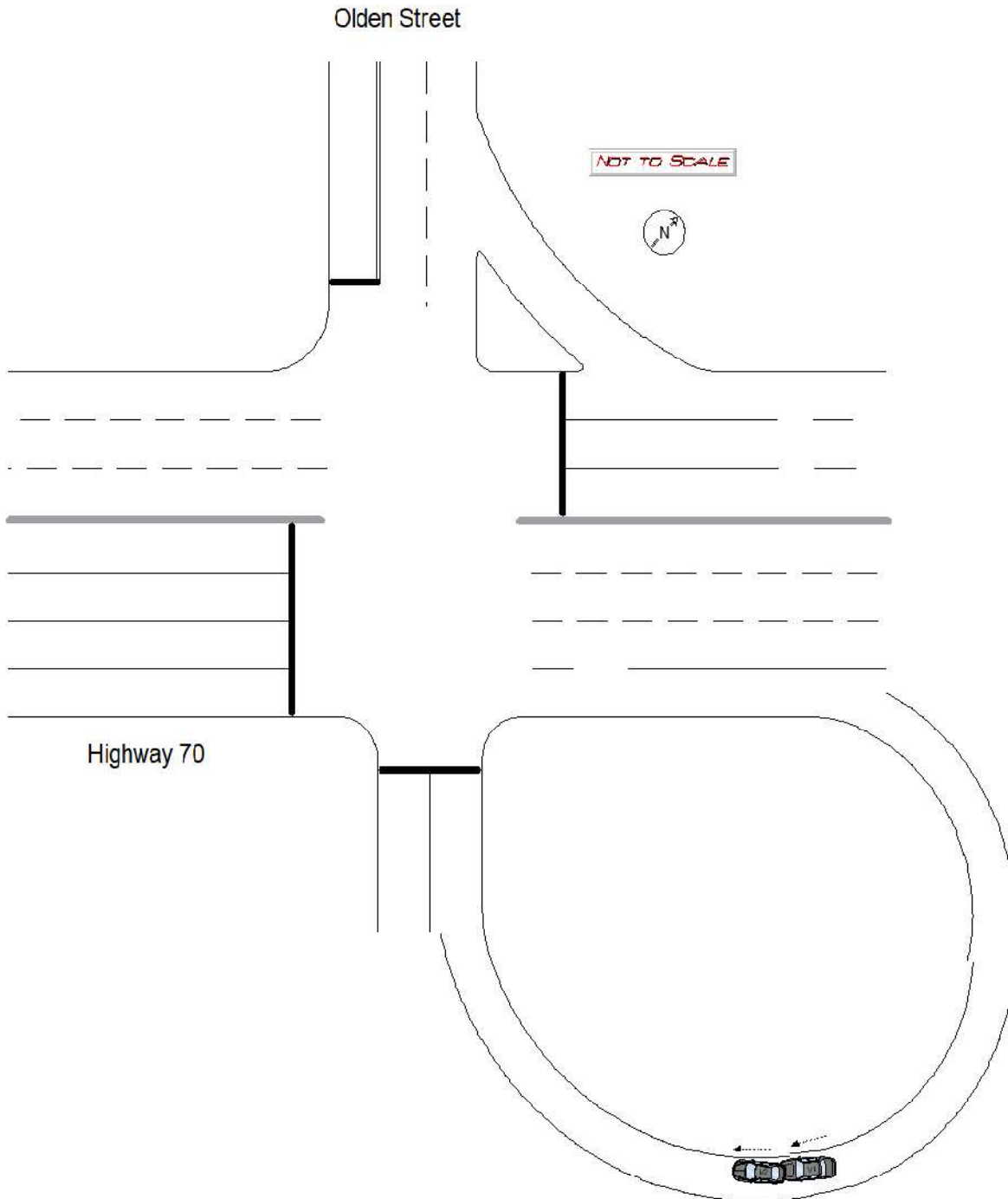
