145. Crash Description/Narrative

Vehicle 2 was stopped on the ramp from Rt. 88 to Rt. 70 west waiting for traffic when it was struck from behind by

vehicle 1 who was also on the ramp from Rt. 88 to Rt. 70 west. Driver 2 stated that he was initially stopped

waiting for an opportunity to enter Rt. 70 west from the ramp and at one point believed he was safe to do so and

moved forward but due to the speed of the approaching traffic stopped again and was struck from behind by vehicle

1. Driver 1 stated that while waiting behind vehicle 2, he observed it move forward to enter Rt. 70. Believing

vehicle 2 was continuing onto Rt. 70, he looked back to the left for approaching traffic while moving forward and

collided with the rear of vehicle 2 who had stopped and not entered Rt. 70. Both vehicles sustained minor damage

and no injuries were reported at this time. The investigation found driver 1 to be at fault for the crash as he

failed to look ahead while moving forward and colliding with vehicle 2 who had stopped in front of him.

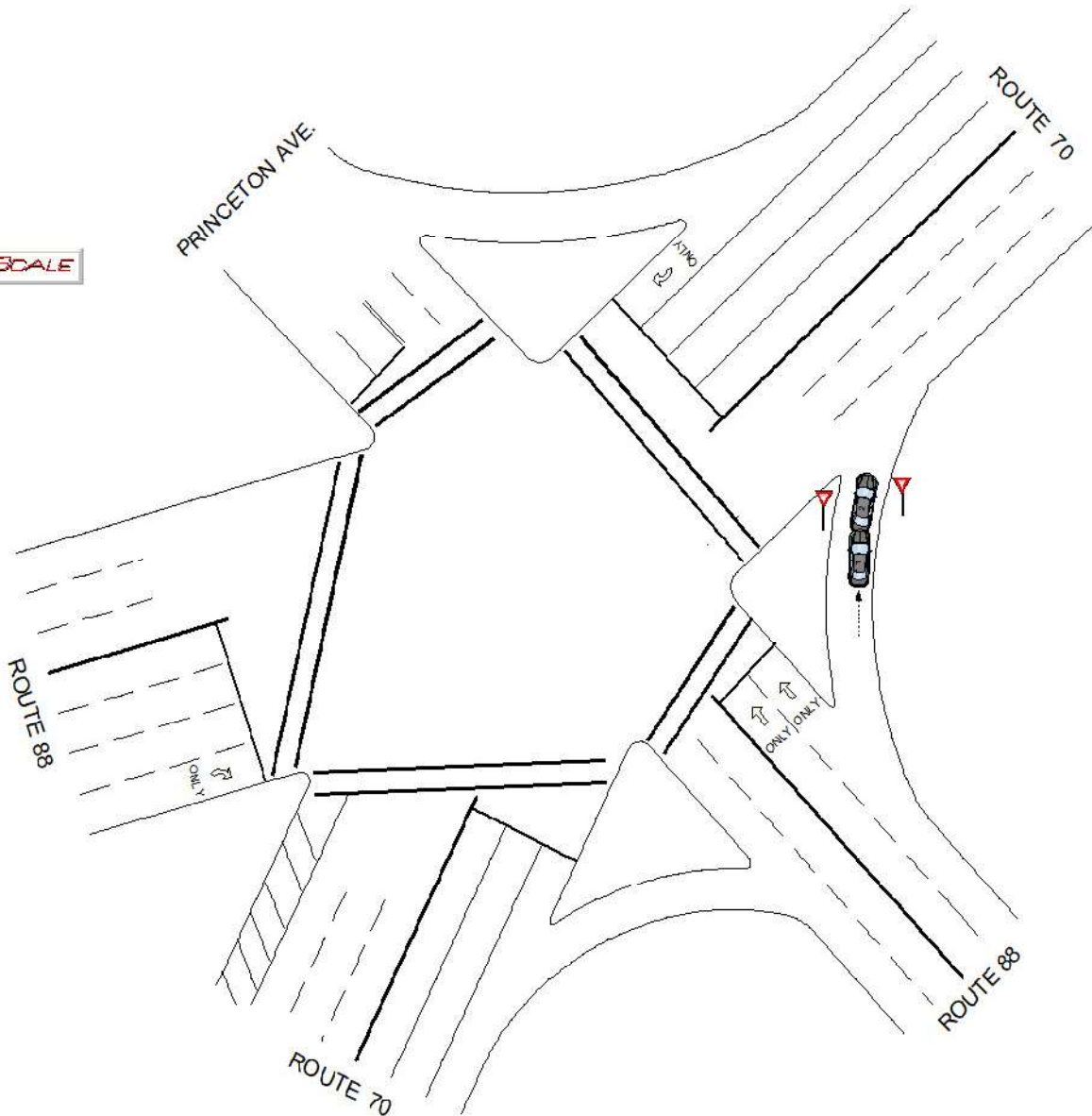
