145. Crash Description/Narrative

My investigation revealed the following:

Vehicle 1 was on the ramp from Route 88 to Route 70 West. Vehicle 2 was on the same ramp directly in front of vehicle 1 and was stopped waiting for traffic to clear. Vehicle 1 accelerated and subsequently struck the rear of vehicle 2.

Driver 1 stated she was on the ramp from Route 88 onto Route 70 behind vehicle 2. She believed vehicle 2 had proceeded onto Route 70. Driver 1 was looking to the left and believed she had enough time to accelerate onto Route 70. When she did so she subsequently struck the rear of vehicle 2.

Driver 2 stated she was stopped at the Yield sign on the ramp from Route 88 to Route 70. She was waiting for traffic to clear when she was struck in the rear.

There were no injuries reported at the scene. Vehicle 1 had moderate damage to the front bumper, grill, and hood. Vehicle 2 had minor scraping on the rear bumper. Based upon the circumstances of the crash I find driver

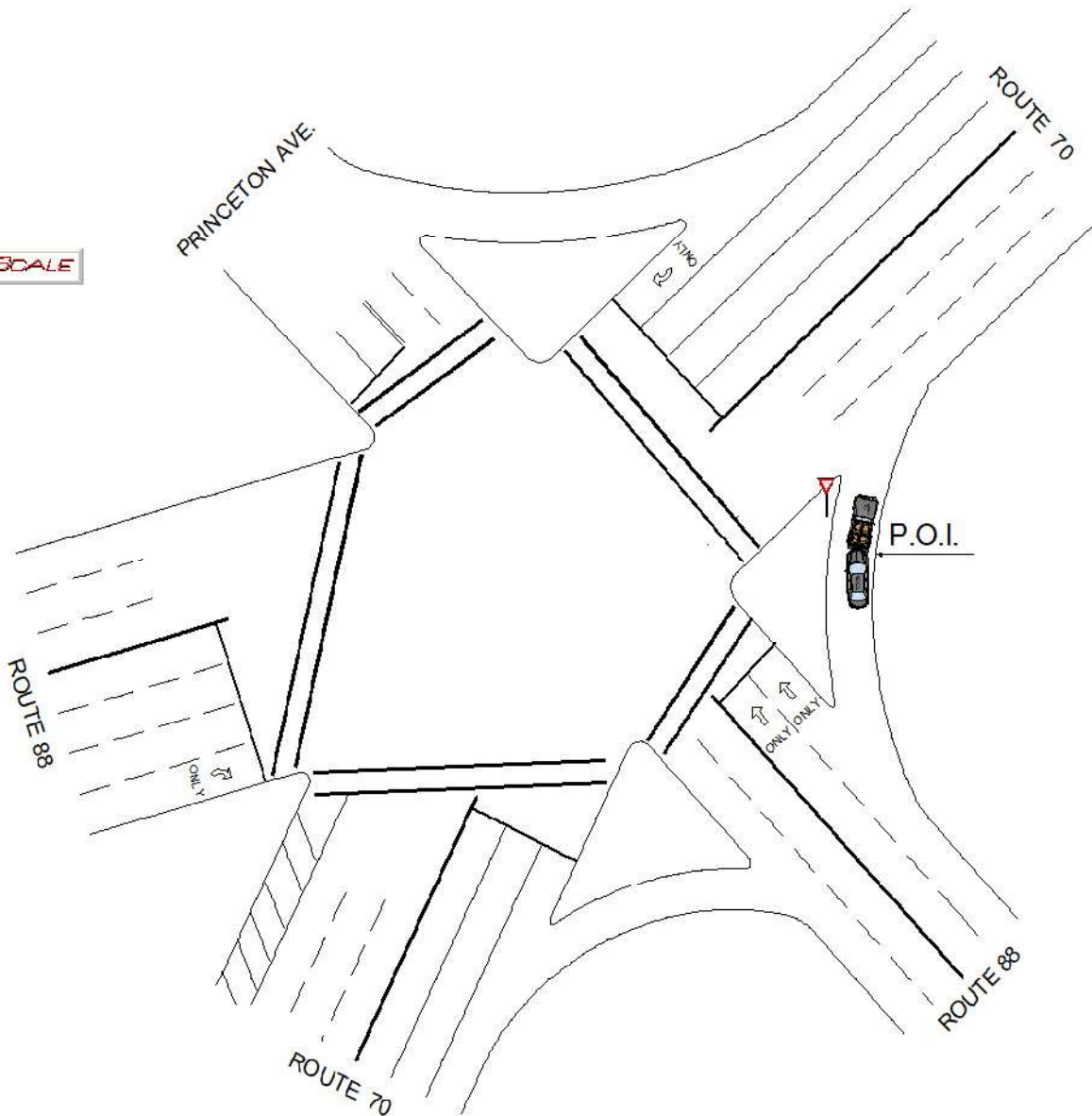
