145. Crash Description/Narrative

Vehicle #1 was stopped in traffic behind Vehicle #2, on Rt 70 W/B approximately 100 feet east of Olden St.

While traffic was stopped, Vehicle #1 rolled into Vehicle #2. After being asked to pull vehicles out of traffic and onto the shoulder, Vehicle #1 bumped Vehicle #2 from behind again. (See C# 2021-00024930)

The driver of Vehicle #1 advised officers on scene that his foot slipped off of the brake pedal while traffic was stopped, causing his vehicle to crash into the rear bumper of Vehicle #2.

The driver of Vehicle #2 stated that he was stopped in traffic at the aforementioned location when he was bumped from behind by Vehicle #1.

After further investigation on scene, the driver of Vehicle #1 was arrested for DUI (See Ptl Knehr's #295 report same case number).

No injuries were reported on scene.
