145. Crash Description/Narrative

On 06/21/2021 at approximately 1849 hrs. I responded to the intersection of RT 88 and Younger Street for a report of a motor vehicle accident. Investigation on scene revealed: V1 was traveling east on RT 88 attempting to make the left turn onto Younger Street. V2 was traveling west on RT 88 going straight through the aforementioned intersection. Driver 1 did not see V2 coming and attempted to make the left turn onto Younger Street but was struck by V2 on the passenger side door panels. I observed damage on the front passenger side of V1 and minor damage on the front bumper of V2.

I spoke with the driver of V1, Paloma Perez, who stated she was traveling east on RT 88 and was attempting to make the left turn onto Younger Street. Perez stated she did not see V2 at the time of her turn and was struck on the passenger side of her vehicle. She believed driver 2 may have been speeding. Perez complained of pain to her back and was checked out by Brick EMS. She refused further medical attention.

I then spoke with Driver 2, Danny Hill, who stated while traveling west on RT 88, he observed V1 making a left turn onto Younger Street. He attempted to stop but his vehicle began to skid striking V1 on the passenger side

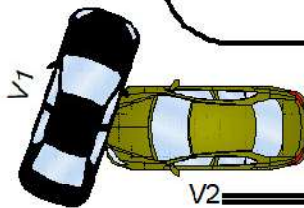
