145. Crash Description/Narrative

Two vehicle crash occurred on 7/2/2021 at approximately 1420 hours on Route 70 westbound near the intersection with Olden St. My body worn camera was on during this investigation.

Driver of vehicle #1 advised he was traveling along the shoulder on Route 70 westbound towards the intersection with Olden St. when vehicle #2 abruptly entered the shoulder in front of him causing him to impact the front right of vehicle #2 with the front left of his vehicle.

Driver of vehicle #2 advised he was traveling slowly in traffic in the right lane on Route 70 westbound when he put on his right blinker and merged into the shoulder ahead of vehicle #1. Driver of vehicle #2 stated he checked his mirror prior to merging into the shoulder and believed it was clear. Driver of vehicle #2 advised he was struck in the right front by the left front of vehicle #1.

I observed moderate disabling damage to the right front wheel and fender of vehicle #2 and minor damage to the left front bumper of vehicle #1.

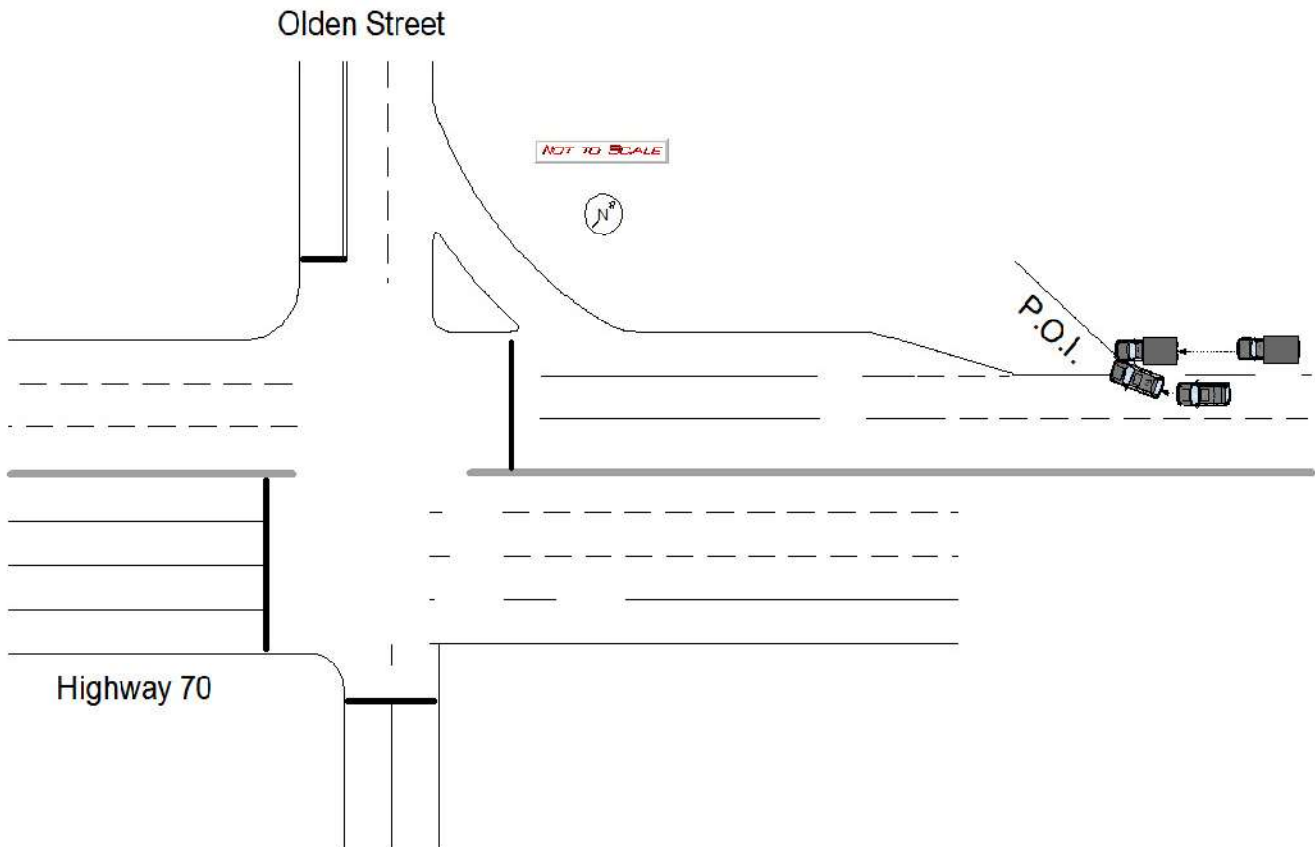
