145. Crash Description/Narrative

Vehicle #1 collided with Vehicle #2 in a rear end crash on the ramp from RT 70 westbound to Olden Street northbound.

The Driver of Vehicle #1 stated he was traveling westbound on RT 70 when he entered the ramp to Olden Street (northbound). Driver #1 stated Vehicle #2 yielded at the yield sign and then after traffic passed Vehicle #2 traveled forward. Driver #1 stated at that time he looked to his left for oncoming traffic from the RT 70 jughandle. Driver #1 stated as he looked to his left he took his foot off the brake pedal and struck Vehicle #2 from behind. Vehicle #1 had minor front end damage. Driver #1 had no reported injuries.

Driver of Vehicle #2 stated she yielded at the yield sign on Olden Street. Driver #2 stated she traveled forward slowly before coming to a complete stop for oncoming traffic traveling northbound on Olden Street. Driver #1 stated when at a complete stop Vehicle #1 struck her Vehicle from behind. Vehicle #2 had minor rear end damage.

It should be noted Driver #2 originally advised she had no injuries. However after speaking with Driver #1 he
