145. Crash Description/Narrative

A motor vehicle crash occurred on Route 70 west approximately 500 feet west of Route 88. The crash occurred in the area of Hobbie, Corrigan and DeCarlo Attorneys, 848 Route 70.

Driver of Vehicle #1 advised he was traveling on Route 70 westbound in the left lane of travel. The vehicle in front of him moved into the right lane suddenly. Driver #1 observed Vehicle #2 stopped in traffic in front of him. He attempted to stop, but struck the rear of Vehicle #2.

There was front airbag deployment of Vehicle #1. There was extensive damage to the front of Vehicle #1. Vehicle #1 was towed by Point Pleasant Towing Department.

Driver of Vehicle #2 advised she was stopped in traffic on Route 70 westbound in the left lane of travel. Driver #2 advised she was struck from behind by Vehicle #1, which in turn caused her to strike the rear of Vehicle #3.

There was front airbag deployment from Vehicle #2. There was extensive damage to the rear of Vehicle #2 and also the front driver side bumper. Vehicle #2 was towed by Joe's Service Center.

Driver of Vehicle #3 advised he was stopped in traffic on Route 70 westbound in the left lane of travel. Driver #3 advised he was struck from behind by Vehicle #2.

There was moderate damage to the rear passenger side of Vehicle #3.

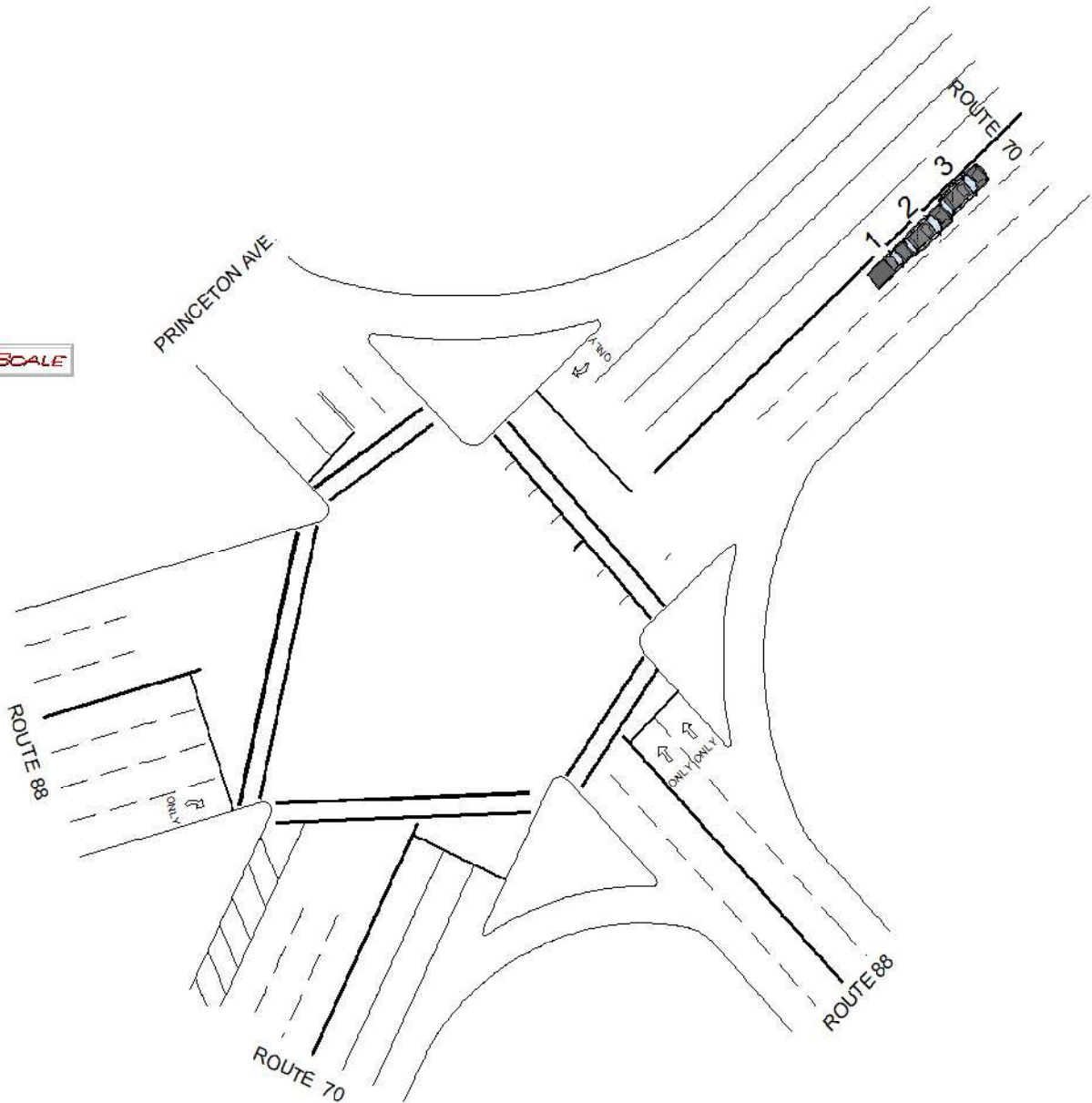
