145. Crash Description/Narrative

Vehicle 1 was traveling west on Route 88 going straight. Vehicle 2 was attempting to make a left turn out of the Tuscany Restaurant parking lot (1490 RT 88). Vehicle 2 failed to yield the right of way of traffic and Vehicle 1 struck Vehicle 2 in the left side. Vehicle 1 attempted to avoid Vehicle 2 but struck Vehicle 2 and swerved left into a dumpster in (1481 RT 88) parking lot. The dumpster then struck Vehicle 3 parked and was unoccupied in the right upper side. Vehicle 1 received moderate damage to the front right lower side. Vehicle 2 received moderate damage to the left middle side. Vehicle 3 received minor damage the right upper side panel. The dumpster was damaged on the right side.

Driver of Vehicle 1 stated she was traveling west on RT. 88. Driver 1 stated she saw Driver of Vehicle 2 pull out of the parking lot but it was too late when she tried to avoid the Vehicle 2. Driver of Vehicle 1 stated she struck Vehicle 2 and then struck a dumpster.

Driver of Vehicle 2 stated she was attempting to make a left turn out of the Tuscany Restaurant parking lot.

Driver of Vehicle 2 stated she did not see Vehicle 1 when she was attempting to turn. Driver of Vehicle 2 stated the crash was her fault.

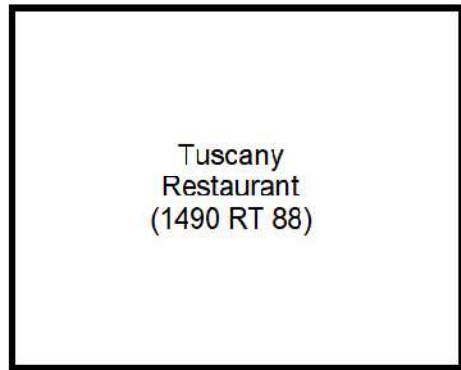
