145. Crash Description/Narrative

As vehicle 1 was backing out of a parking space in the parking lot of 1640 Rt. 88, it struck vehicle 2 which was unoccupied and legally parked in the space to the right. Driver 1 stated that as she was backing out, she "cut" the wheel to far and it caused her to strike the rear bumper of vehicle 2 with her front right tire. No damage was observed to vehicle 1 as it had only made contact with it's front right tire. Vehicle 2 sustained minor damage to the left side of the rear bumper/fender. No injuries were reported at this time and both vehicles were driven from the scene. The registered owner of vehicle 2 stated that upon arriving at her vehicle prior to the crash, vehicle 1 was parked so close to her vehicle she could not get in. She asked the occupants of vehicle 1 to move and they complied but struck her vehicle in the process of backing out of the space.

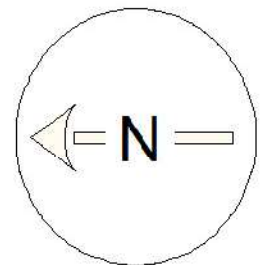
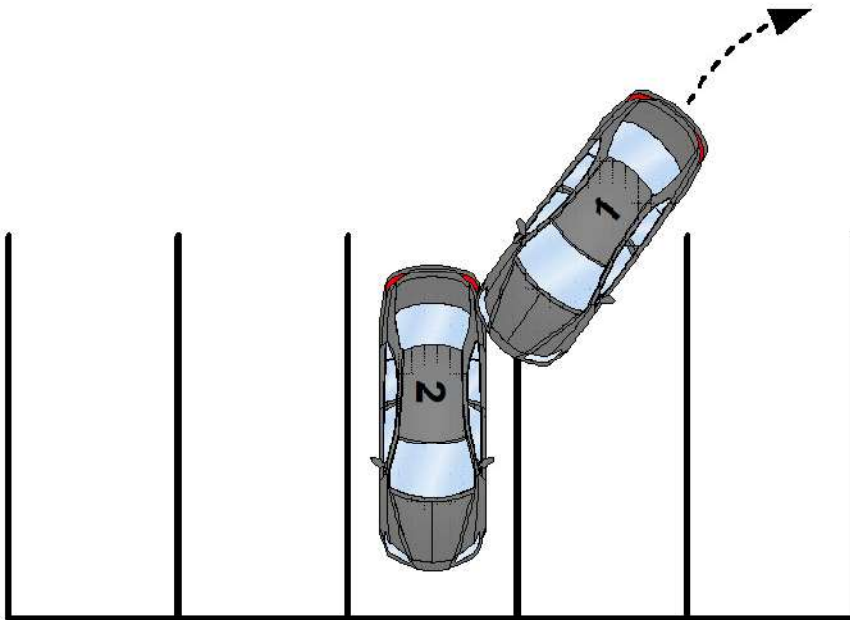
