145. Crash Description/Narrative

On scene investigation:

After speaking with both drivers and observing the damage to both vehicles. It was determined that Vehicle 2 was stopped at the yield sign waiting to turn right onto RT 70 west at the intersection of RT 88 / RT 70. Vehicle 1 was stopped behind Vehicle 2, also waiting to complete the right turn onto RT 70 west. Vehicle 1 then briefly accelerated and collided with the rear end of Vehicle 2.

The driver of Vehicle 2 said that she was stopped waiting to complete the right turn onto RT 70. She advised that she inched forward but came to a stop again. After coming to a stop again, she said that Vehicle 1 then hit her from behind.

The driver of Vehicle 1 also advised that he was stopped waiting to turn right onto RT 70 when he observed Vehicle 2 begin to proceed onto RT 70. He said that he was looking back over his shoulder for oncoming traffic while moving forward. At that time he collided with Vehicle 2.

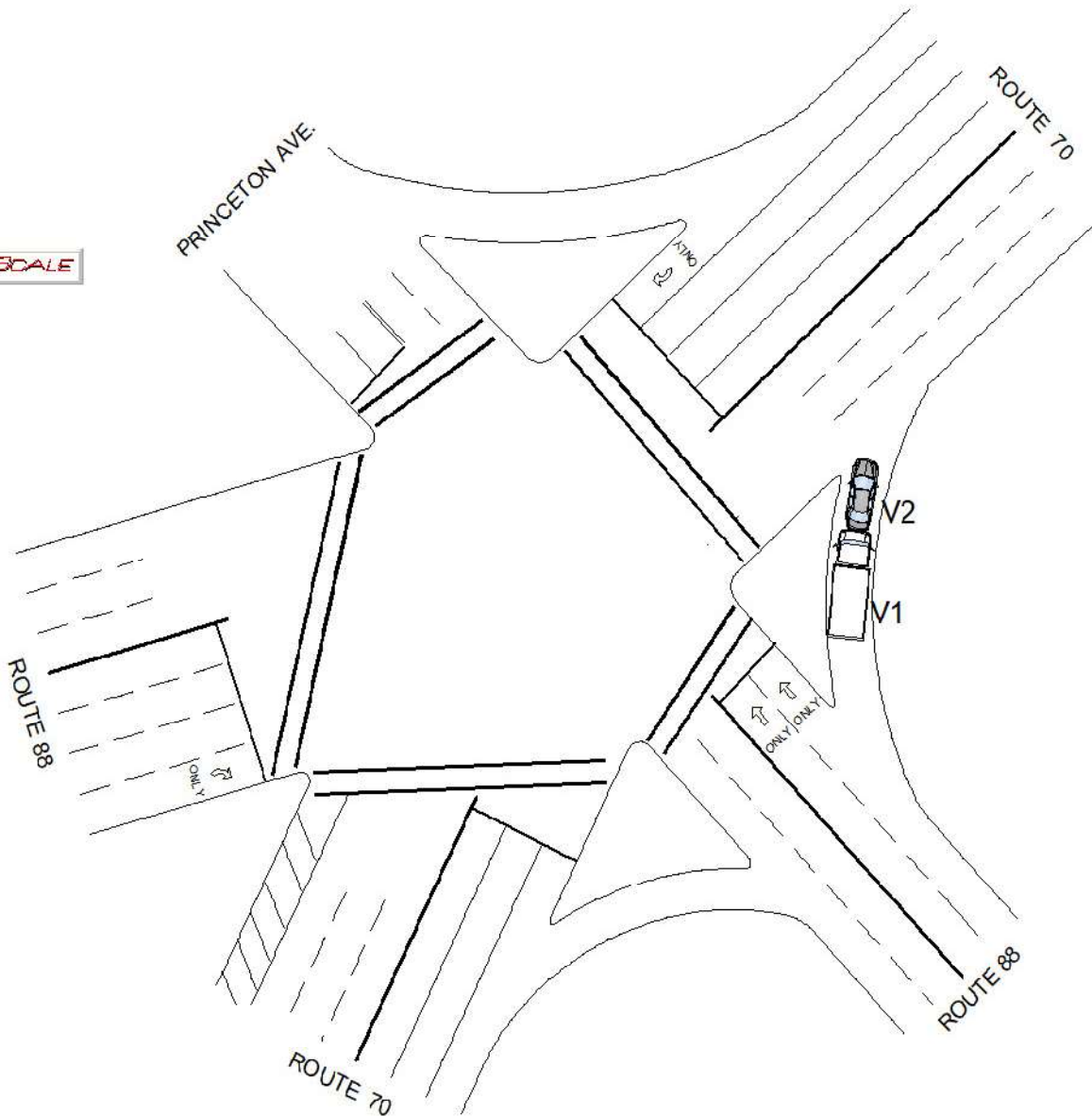
