145. Crash Description/Narrative

Vehicle #1 was traveling west on Route 88 in the center lane approaching the intersection of Route 70. Vehicle #2 was stopped in traffic in the left lane of Route 88 westbound. Vehicle #1 rear ended Vehicle #2 in the left lane.

Vehicle #1 operator stated she was traveling in the center lane with the flow of traffic, approaching the intersection of Route 70. Vehicle #1 operator stated she was observing traffic moving ahead of her and changed lanes into the left lane when she impacted Vehicle #2. Vehicle #2 operator stated she did not see Vehicle #2 was stopped in traffic ahead of her. Vehicle #2 operator suffered complaint of chest pain from airbag deployment and refused medical attention by Brick Police EMS #532.

Vehicle #2 operator stated he was stopped in traffic when Vehicle #1 forcefully rear ended his vehicle. No reported injuries by the occupants of Vehicle #2. All occupants were assessed and refused medical attention by Brick Police EMS as a precaution.

Vehicle #1 operator was determined to be at fault for unsafe lane change and driver inattention. Vehicle #1

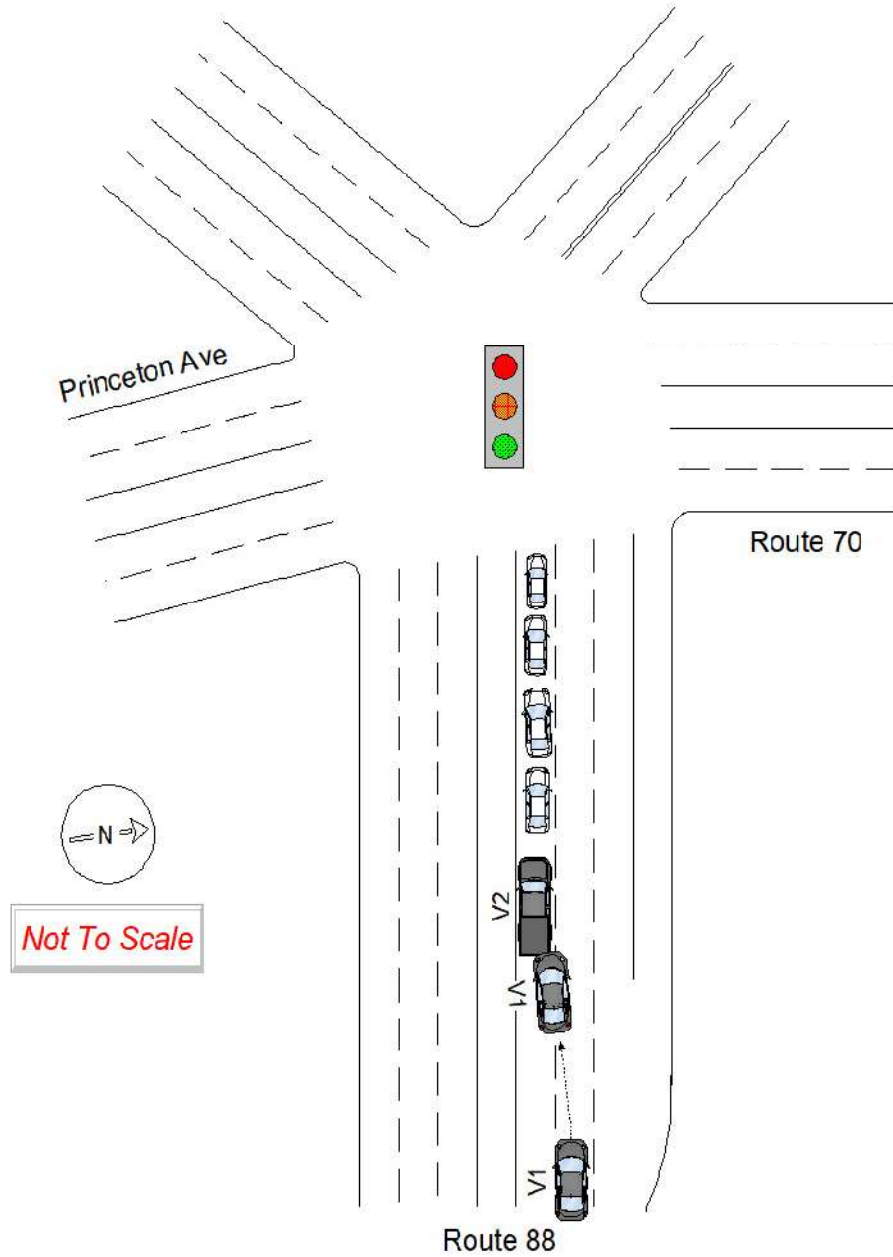
