145. Crash Description/Narrative

Both Vehicle 1 and 2 were backing out of parking spaces on the property of 1872 Route 88. While they were backing out of their spots both Vehicles backed into each other.

Driver 1 stated the following: he was backing out of his parking space of 1872 Route 88. While he was backing out he never saw Vehicle 2 backing out of another parking space in the parking lot of 1872 Route 88, and he backed into Vehicle 2.

Driver 2 stated the following: he was backing out of his parking space of 1872 Route 88. While he was backing out of his spot Vehicle 1 began to back out of a different parking space in the parking lot of 1872 Route 88 and backed into his vehicle.

There was no reported injuries on scene. Both Vehicles were moved prior to my arrival. Vehicle 1 was left on scene. Vehicle 2 was driven from the scene. Driver 1 was issued summons E21-004976 for 39:3-4 Driving or parking an unregistered vehicle.

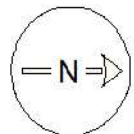
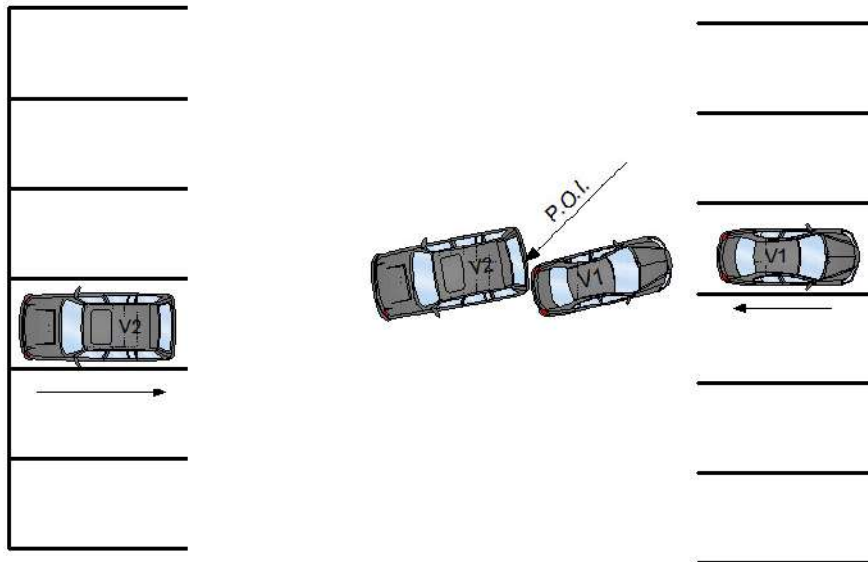
