145. Crash Description/Narrative

Vehicle #1 was traveling westbound on Olden Street approaching the intersection of Route 88. Vehicle #2 was stopped in westbound traffic on Olden Street at the intersection of Route 88. Vehicle #1 rear ended Vehicle #2.

Vehicle #1 operator left the scene on foot prior to my arrival. Vehicle #1 was left unattended in the parking lot of Laurelton Fire Company #23.

Vehicle #2 operator stated he was rear ended by Vehicle #1 while stopped in traffic at the intersection of Olden Street and Route 88. Vehicle #2 operator stated the Vehicle #1 operator walked away from the scene.

Vehicle #1 suspect operator was described as a white female 5'5" thin build, approximately 30 years old with brown hair and tattoos. A check of the immediate area was negative.

Upon further investigation, I responded to an associated address of Vehicle #1 (20 Rose Manor Court). Vehicle #1 owner was on location and stated he did not know who was operating the vehicle earlier and was not forthcoming with information. Vehicle #1 operator did have the keys at this location and was with a female matching the

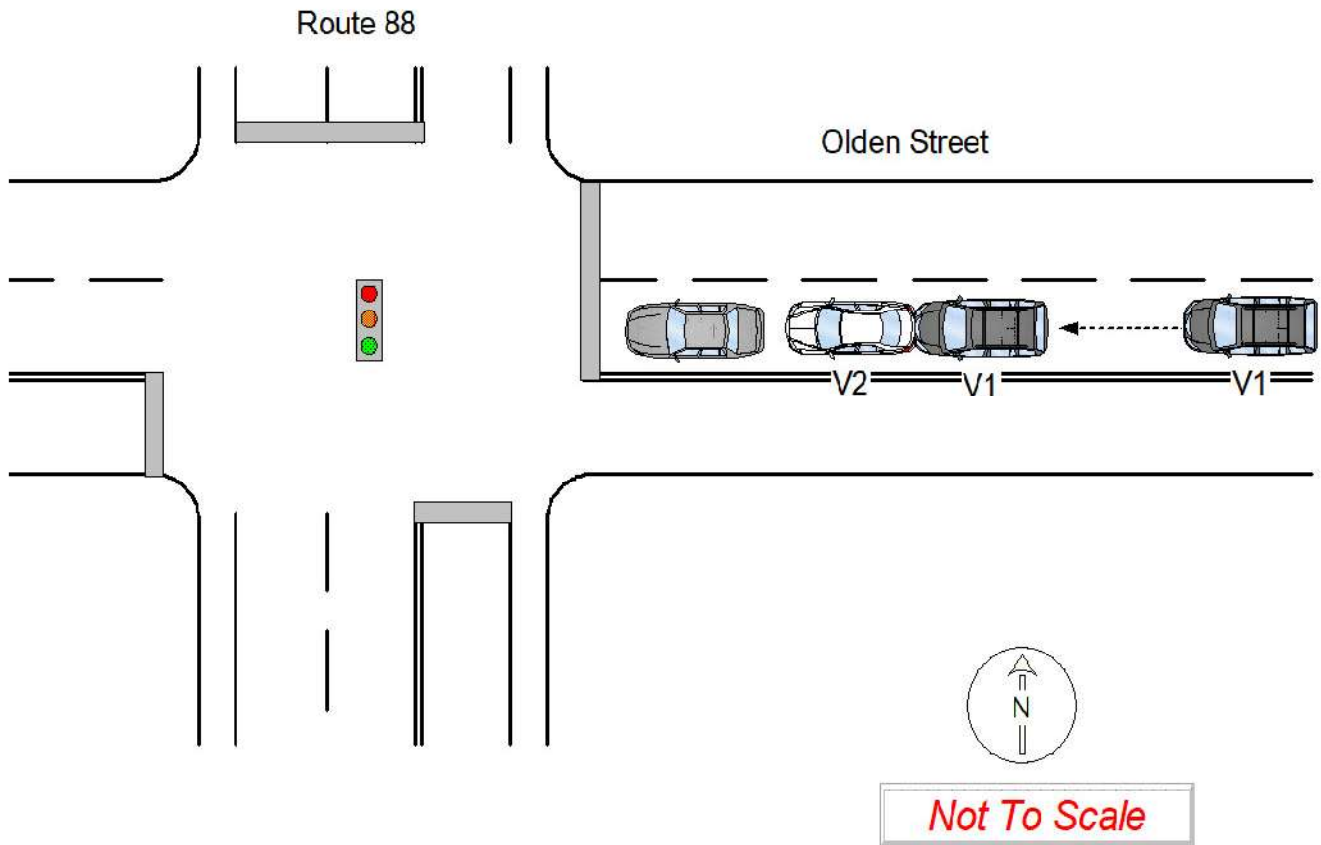
