145. Crash Description/Narrative

Vehicle one was parked, facing East, in an assigned parking spot at Walmart. Vehicle two was parked, facing West, in an assigned parking spot at Walmart. Vehicle one began backing out of the parking spot traveling West. Vehicle two began backing out of their parking spot traveling East. Vehicle one and vehicle two were both in motion and struck each other in the rear passenger side bumper. Driver one advised that they were both backing out when their rear bumpers struck. Driver two advised that both vehicles were in motion when the vehicles tapped bumpers. I observed that vehicle one sustained scratches on the rear bumper and the bumper was pushed slightly out of place. Vehicle two sustained a significant dent to the rear passenger side bumper which was pushed out of alignment. After speaking to both driver's I determined that both drivers were at fault since both vehicles were in motion and neither driver observed the other vehicle. No injuries were reported and both vehicles were driven from the scene.

Motor Vehicle Crash Diagram

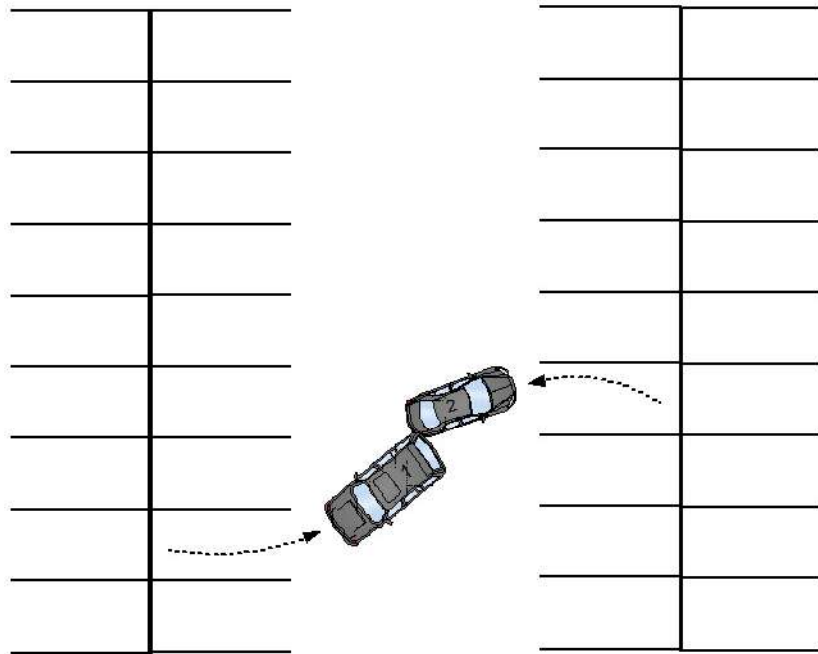
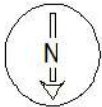
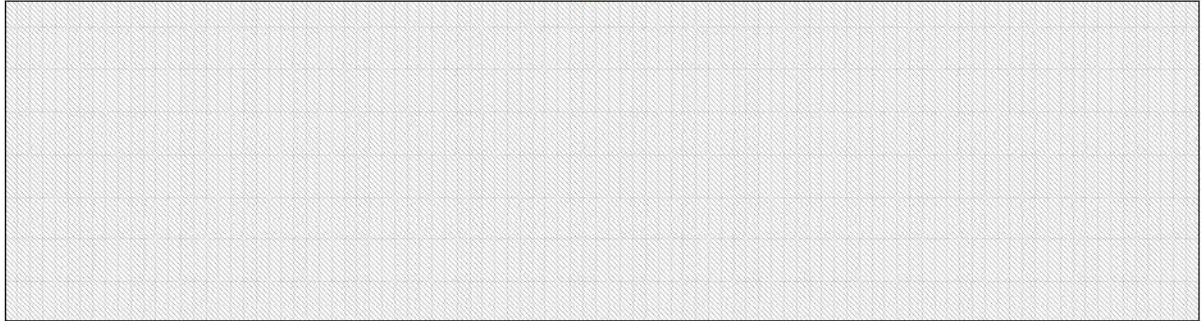
