145. Crash Description/Narrative

Vehicle 1 was traveling westbound on Rt. 88, approaching the intersection of Younger St. Vehicle 2 was traveling southbound in the Walmart parking lot, approaching Rt. 88 westbound.

Vehicle 1 pulled off the roadway, into the shoulder on the right side of the roadway on Rt. 88. Vehicle 1 began backing eastbound in the shoulder. Vehicle 2 was attempting a right turn onto Rt. 88 westbound. The rear of Vehicle 1 struck the front of Vehicle 2.

Driver 1 stated she had missed the entrance to Walmart, pulled into the shoulder, and reversed in the roadway in an attempt to make it to the entrance she had missed. Driver 2 stated that she was attempting a right turn onto Rt. 88 after coming to a complete stop at the stop sign when Vehicle 1 struck her vehicle.

Both vehicles were slightly moved prior to my arrival.

Driver 1 was issued E21-4766 for 39:4-127 Improper Backing in the Roadway and Warning E110001 for 39:4-97a Careless Driving.

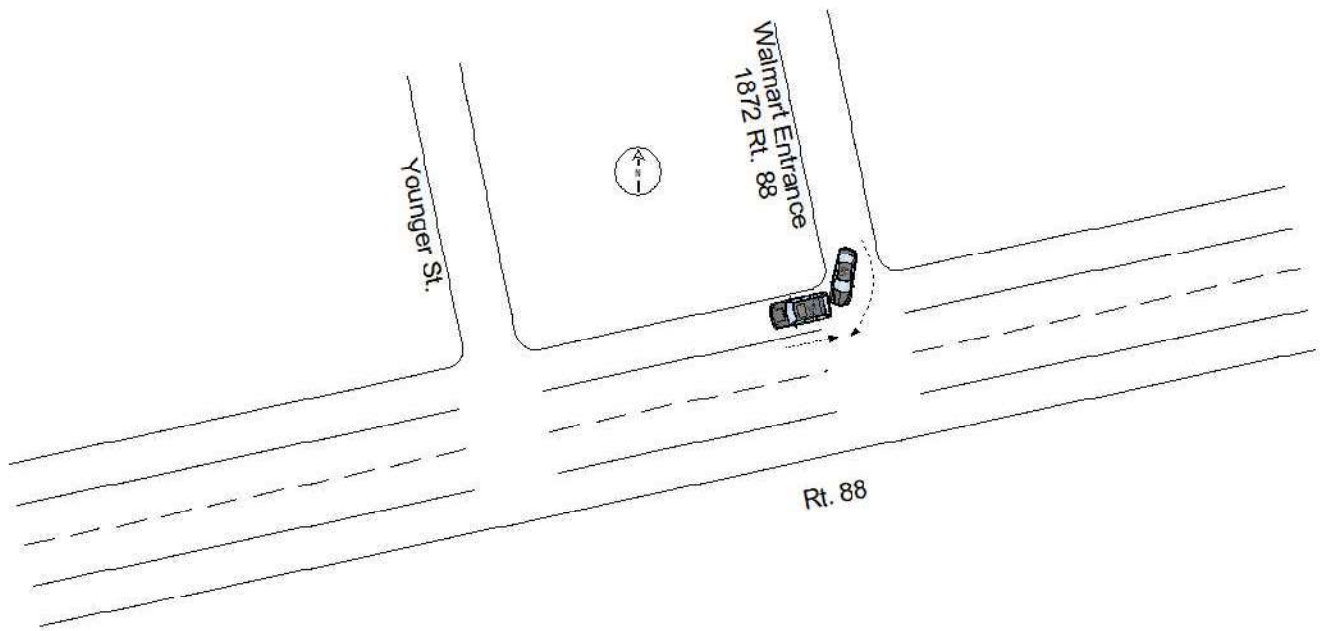
