145. Crash Description/Narrative

A motor vehicle crash occurred on Route 88 approximately 50 feet east of the intersection to Post Road.

Driver of Vehicle #2 advised she was traveling on Route 88 westbound in the right lane of travel towards Post Road. Driver #2 advised Vehicle #1 moved into the right lane from left lane, striking the rear driver side door of her vehicle.

There was minor damage to the rear driver side door of Vehicle #2.

Driver #2 advised after the crash, she pulled into the cemetery parking lot with Vehicle #1. She advised when she said she was calling the police for a report, Vehicle #1 driver became agitated and left the scene. Driver #2 described him as an older white male with gray hair, short with a slight beard. He was also wearing a Wal Mart vest with a name tag of Donald on it. She could not describe the vehicle, but knew the first three characters of the NJ Reg were Z93.

Dispatch conducted a lookup of the NJ Reg and found one for Vehicle #1 (NJ Reg Z93NDT).

145 Crash Description

I traveled to Vehicle #1's address and spoke with him. He advised while traveling to his house from work, he attempted to go around the vehicle in the left lane which was turning left onto Post Road. He advised he thought he was clear when he began to move into the right lane of travel. He advised the vehicle in front of him starting beeping and he moved into the parking lot with the vehicle. He stated Driver #2 never advised him she was calling the police.

There was minor damage to the front passenger wheel well of Vehicle #1.

While changing lanes, Vehicle #1 struck Vehicle #2 which was traveling straight in her lane of travel. Driver #1 is the at fault driver for improper lane change and failure to yield right of way to vehicle.

Driver #1 was issued the following summonses: 1506 T 163128 for 39:4-129, leaving the scene of an accident; 1506 T 163129 for 39:4-140, failure to report an accident; and 1506 T 163130 for 39:4-97, careless driving.

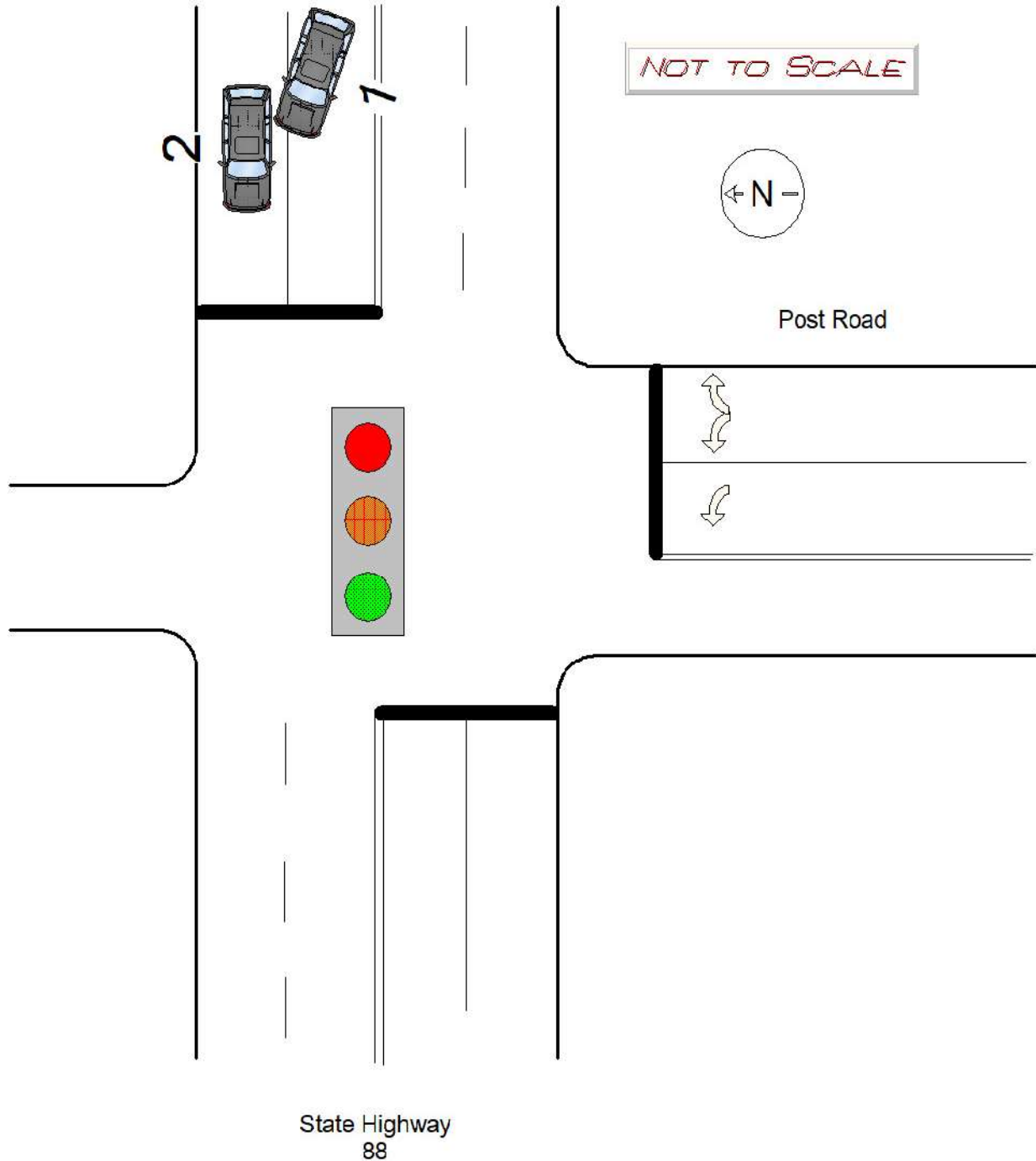
