145. Crash Description/Narrative

On July 22, 2021 I responded to the area of Route 88 and Post Road for a motor vehicle crash. On arrival, three vehicles were in the parking lot of 1820 Route 88. Upon arrival, I observed minor damage to all vehicles.

Vehicle #1 had minor damage to the front of her vehicle. Vehicle #2 had minor front and rear damage to her vehicle. Vehicle #3 had minor damage to the rear of his vehicle.

Driver #3 explained they were stopped at the traffic light of Route 88 and Post Road when vehicle #2 crashed into the rear of his vehicle.

Driver #2 explained he was stopped behind vehicle #3 when he was rear ended by Vehicle #1.

Driver #1 explained she was slowing for the traffic light when she could not stop in time causing her to crash into the rear of Vehicle #2.

After my investigation and the admission of Driver #1, I found Driver #1 at fault for the crash. There were no

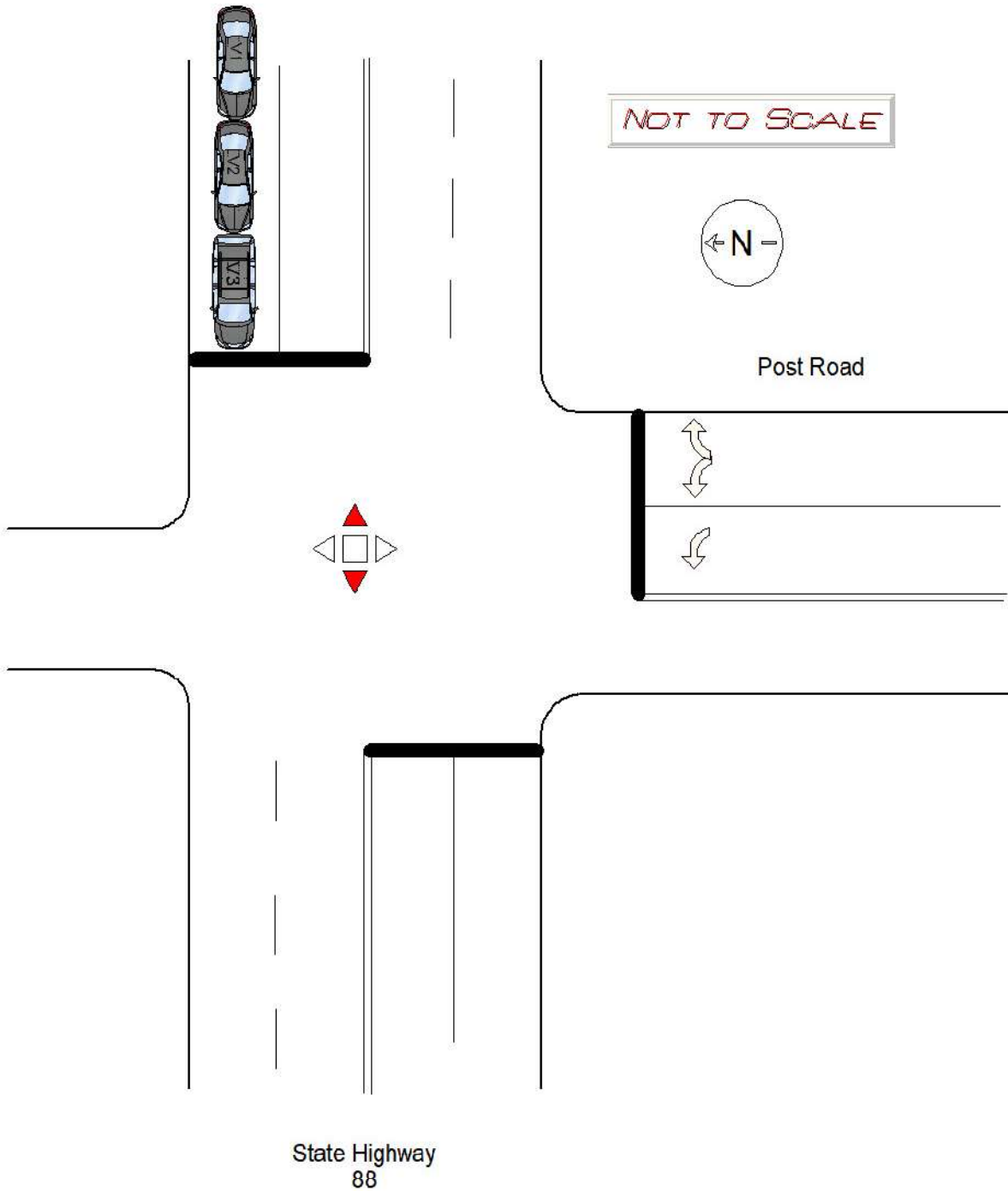
