145. Crash Description/Narrative

Vehicle 1 traveled northbound on Route 70 and entered the ramp leading to Olden Street. Vehicle 2 traveled the same and was in front of Vehicle 1. Vehicle 2 stopped at the traffic signal. Vehicle 1 failed to stop, and the front end of Vehicle 1 struck the rear end of Vehicle 2.

Driver 1 stated he was driving behind Vehicle 2 and came to a complete stop. Driver 1 advised he thought he put his vehicle into park as he began to look for an item in the vehicle. Driver 1 explained he did not realize the car was still in drive until he felt a bump when Vehicle 1 rolled into Vehicle 2.

Driver 2 stated she came to a complete stop on the Route 70 ramp leading to Olden Street because of the red traffic signal. Driver 2 said she felt a jolt when Vehicle 1 rolled into Vehicle 2.

Based on my investigation, Driver 1 is at fault for following too closely and driver inattention. Driver 1 was issued Traffic Summons: 1506 E20 3249 in violation of 39:4-97 (Careless Driving).

No injuries were reported on scene, both vehicles were able to be driven from scene with minor damage.

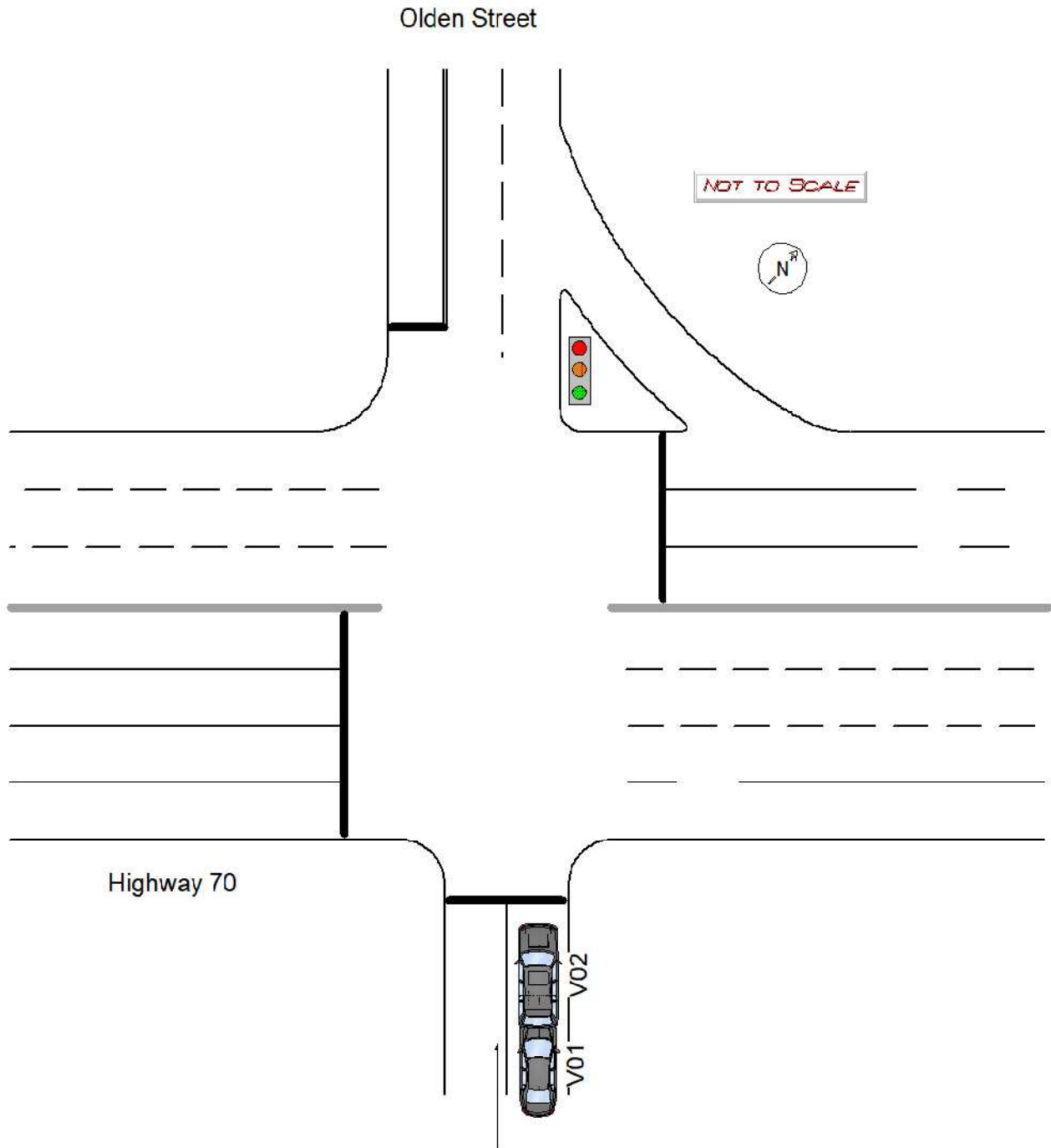
