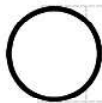

145. Crash Description/Narrative

Vehicle 1 was making a left turn from Post Road onto Route 88. Vehicle 2 was traveling west on Route 88 in the intersection of Post Road. Both Driver 1 and Driver 2 claim to have had the green light at the time of the crash. There was no witnesses, or video surveillance of the intersection at the time, at this time I am unable to determine who failed to stop at the red light, causing the crash.

Driver 1 stated the following: he was making a left turn, from the right lane, of Post Road onto Route 88. While making the left turn he was struck by Vehicle 2 who was traveling west on Route 88 in the intersection of Post Road. Driver 1 stated he had the green light for the intersection when he made the left turn.

Driver 2 stated the following: he was traveling west on Route 88 in the intersection of Post Road. While in the intersection he was struck by Vehicle 1 who was making a left turn onto Route 88 from Post Road. Driver 2 stated he had the green light for the intersection at the time of the crash.

There was no reported injuries on scene. Both Vehicles were moved prior to my arrival. Both Vehicles were driven from the scene by their respected Drivers. A check of the area surrounding the intersection was negative
