145. Crash Description/Narrative

Both Vehicles #1 and 2 were backing out of parking spaces across from one another, in the lot of the Walmart store (1872 Rt 88) and crashed.

Both drivers stated the other was at fault. A look of the surveillance footage showed that Vehicle #1 and Vehicle #2 both started to back out of their spaces at the same time with Vehicle #2 backing somewhat faster.

Neither driver seemed to have seen the other and crashed just passed the center of the aisle.

No injuries were reported on scene.

A video copy of the crash was entered into property.

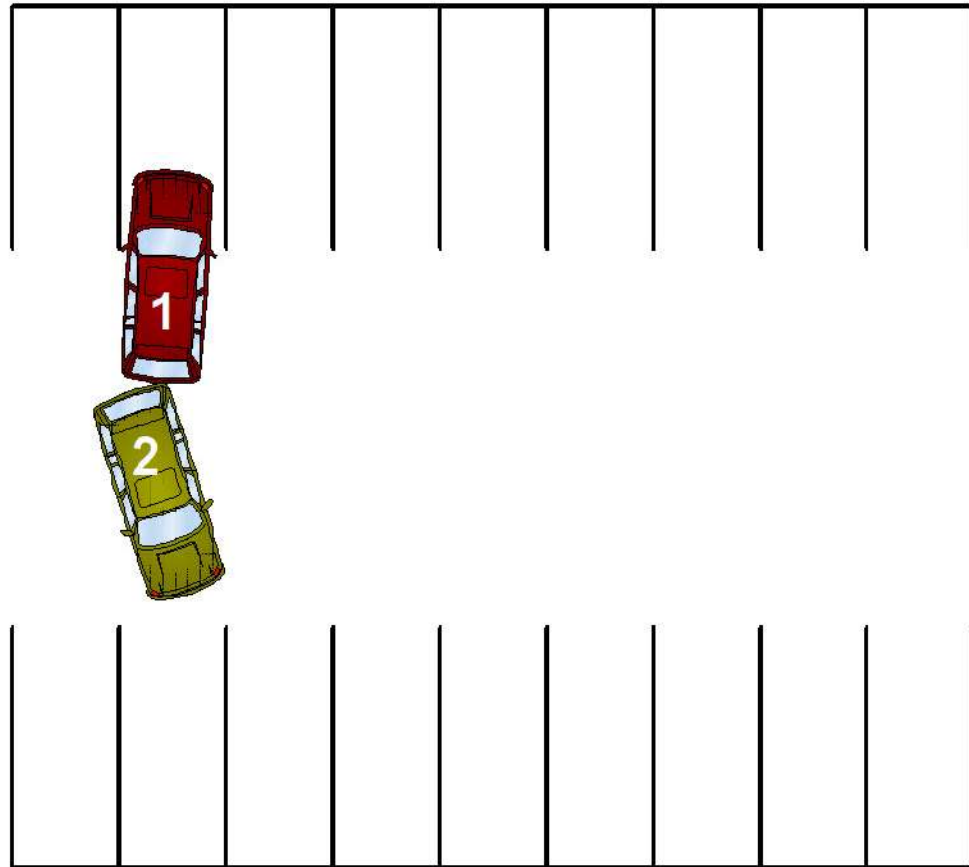
