145. Crash Description/Narrative

On the ramp from Rt 88 east to Rt 70 west Vehicle 01 struck the rear of Vehicle 02.

Driver of Vehicle 02 stated she was stopped at the yield sign on the ramp from Rt 88 east to Rt 70 west waiting for traffic when she proceeded and stopped again, Vehicle 01 struck her in the rear. Driver of Vehicle 02 stated she was not sure what to do as she continued onto Rt 70 and called her mother. Her mother advised her to return to the area of the accident and call the Police. Passenger of Vehicle 02 was able to recover Vehicle 01's plate number.

I responded to Vehicle 01's address and spoke with Driver 01. Driver 01 stated she was behind Vehicle 02 on the ramp from Rt 88 east to Rt 70 west at the yield sign when she bumped into the rear of Vehicle 02. Driver of Vehicle 01 stated she wasn't sure what to do as Vehicle 02 drove off onto Rt 70. Driver of Vehicle 01 stated she had called her mother and responded home to meet with the police. Driver of Vehicle 01 admitted fault.

My investigation revealed Vehicle 01 was at fault.

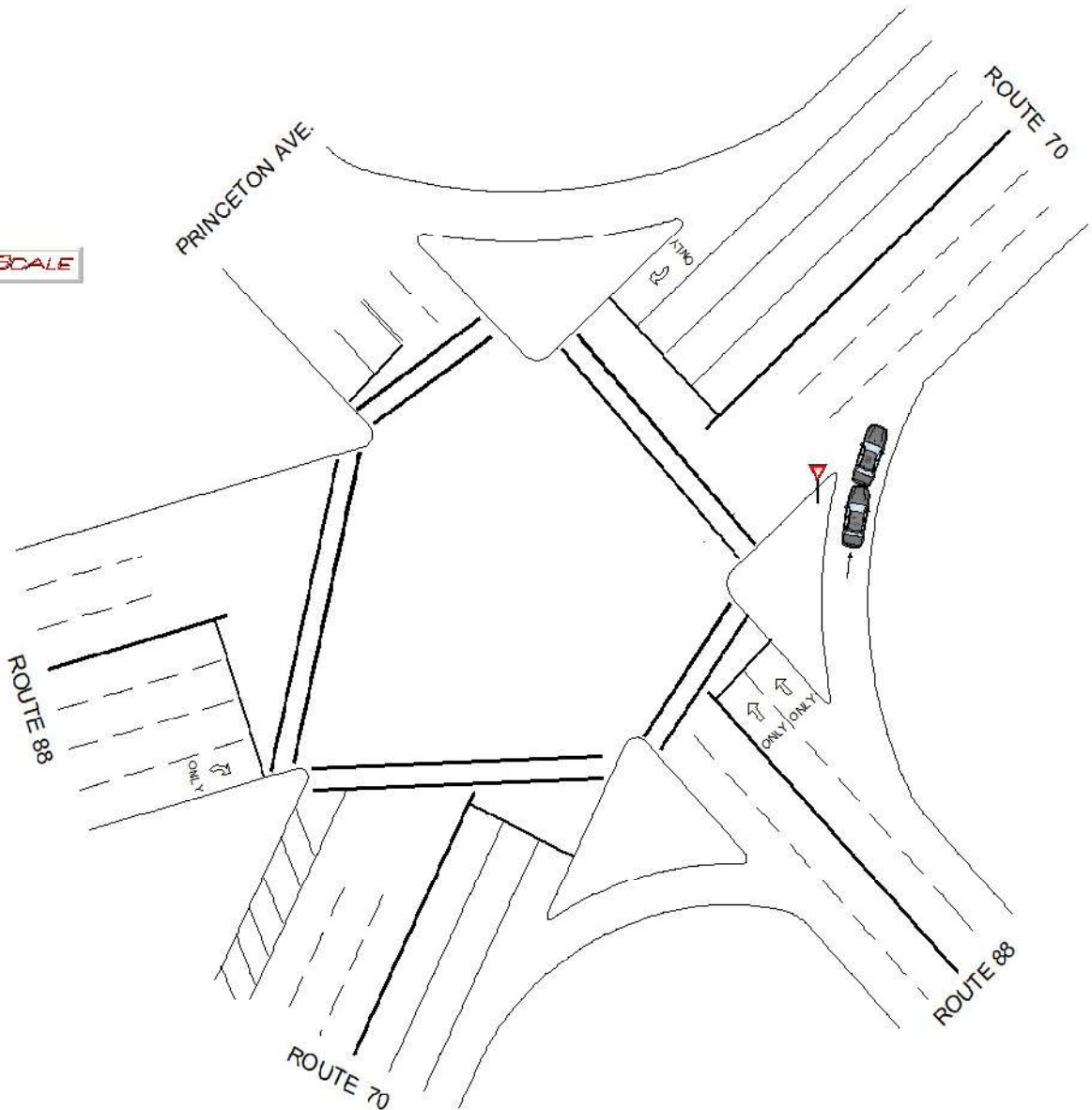
