145. Crash Description/Narrative

My investigation revealed the following:

Vehicle 1 was in the left lane heading West on Route 70 just prior to the intersection with Olden St.

Vehicle 2 was in the same lane stopped in traffic directly in front of vehicle 1. Driver 1 failed to realize traffic had come to a stop and crashed into the rear of vehicle 2.

Driver 1 stated she was in a hurry because she was on her lunch break at work. She observed traffic stopped in front of her just prior to impacting vehicle 2 and was unable to stop in time.

Driver 2 stated she was stopped in traffic in the left lane and was struck in the rear without warning.

Based on the above circumstances I find driver 1 to be at fault for the crash. There were no injuries reported and both vehicles were driven from the scene. Driver 1 was issued a summons for 39:4-97(Careless Driving).

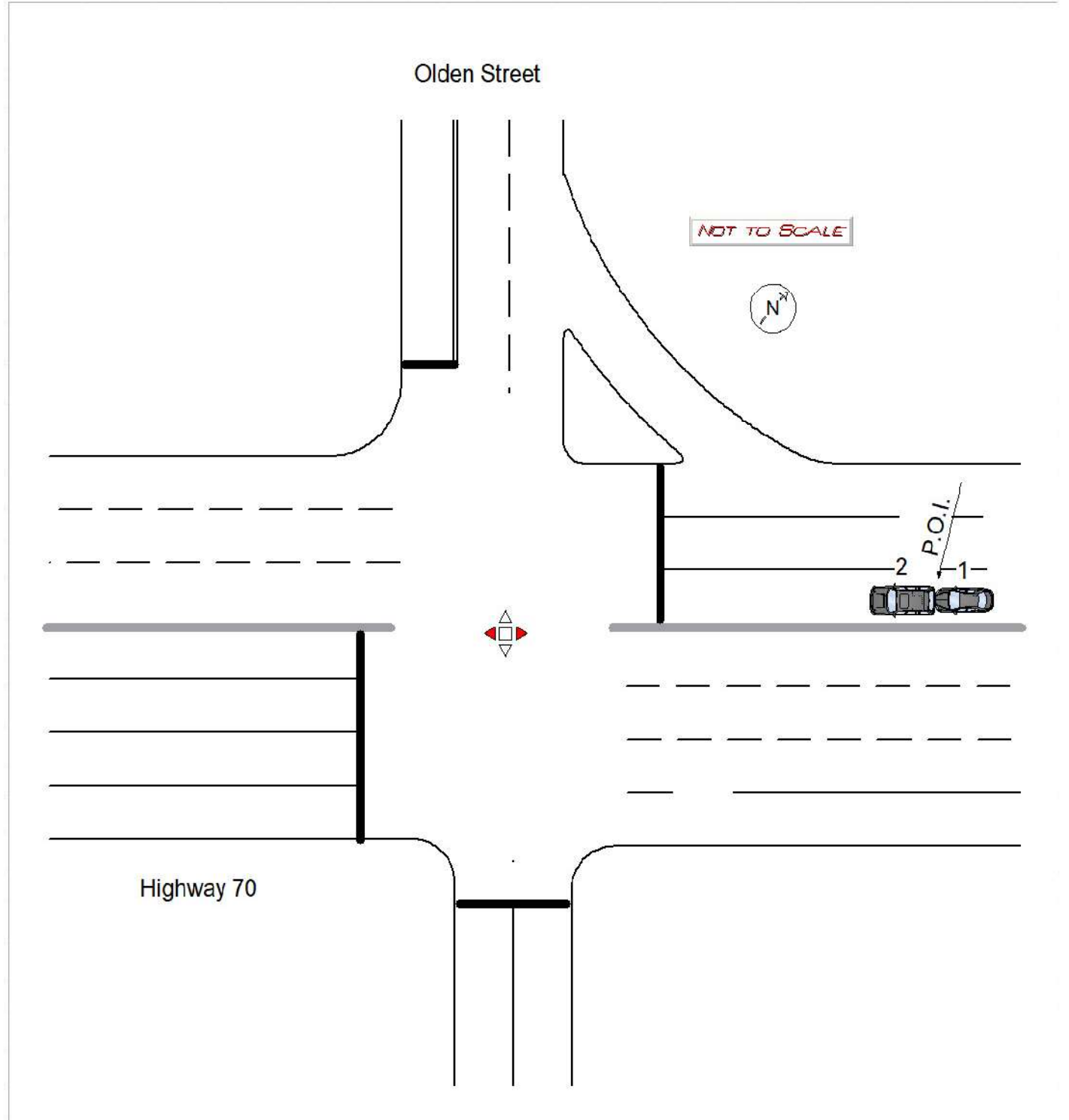
