145. Crash Description/Narrative

Vehicle 02 was stopped on the ramp to Route 70 westbound from Route 88. Vehicle 01 was behind vehicle 02

stopped on the ramp to Route 70 westbound. Vehicle 01 rear ended vehicle 02 while on the ramp.

The driver of vehicle 01 stated she was stopped behind vehicle 02 waiting to enter Route 70 westbound from Route 88. The driver of vehicle 01 thought vehicle 02 proceeded onto Route 70 and was looking over her shoulder waiting for vehicles to enter Route 70. The driver of vehicle 01 saw a opening and began to accelerate not knowing vehicle 02 was still stopped in front of her. Vehicle 01 struck vehicle 02 with its front bumper striking the rear bumper of vehicle 02.

The driver of vehicle 02 stated she was stopped on the ramp to Route 70 westbound from Route 88. While waiting for traffic vehicle 01 rear ended vehicle 02. The driver of vehicle 02 complained of pain in her right foot.

Base on driver statements and evidence I find the driver of vehicle 01 at fault for this crash. During the course of the investigation I found that vehicle 01 had old, not on file license plates on her vehicle. The driver of vehicle 01 stated she needed to drive the vehicle and the license plates were from an old vehicle her

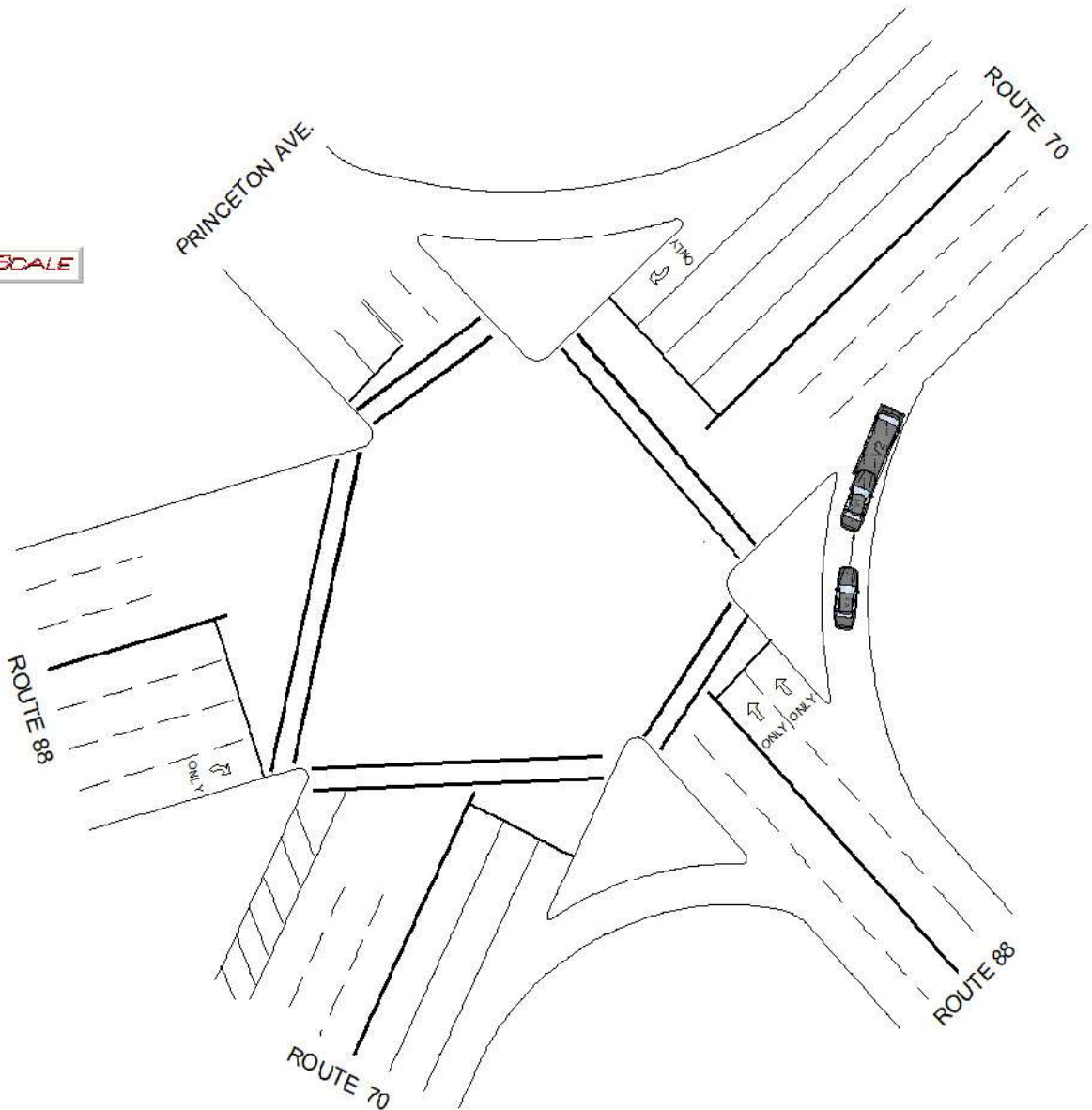
